- Street Opening Permit Prior to the commencement of any digging, alteration or construction within the public right-of-way (streets, alleys, public easements), a street opening permit shall be applied for and obtained by the contractor from the City of Rosnoke.
- 3. Plans and Permits A copy of the plans approved by the City (signed by the proper City officials) and all permits issued by the City shall be available at the construction site at all times of ongoing construction.
- 4. <u>Location of Utilities</u> The contractor shall verify the location of all existing utilities prior to the commencement of any construction.
- 5. Construction Entrance The contractor shall install an adequate construction entrance for all construction related agrees from the site. Size and composition of construction entrance shall be determined by the City site plan inspector.
- Streets to Remain Clean It shall be the responsibility of the contractor to insure that the public street adjacent to the construction entrance remains free of mud, dirt, dust and/or any type of construction materials or litter at all times.
