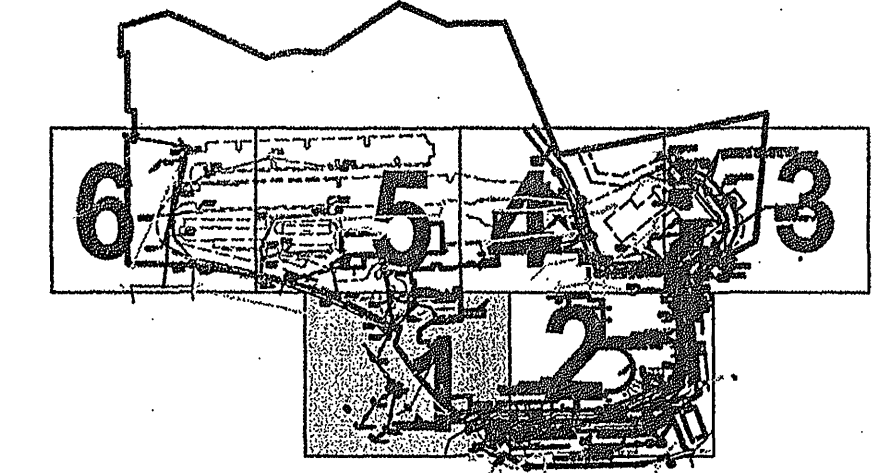
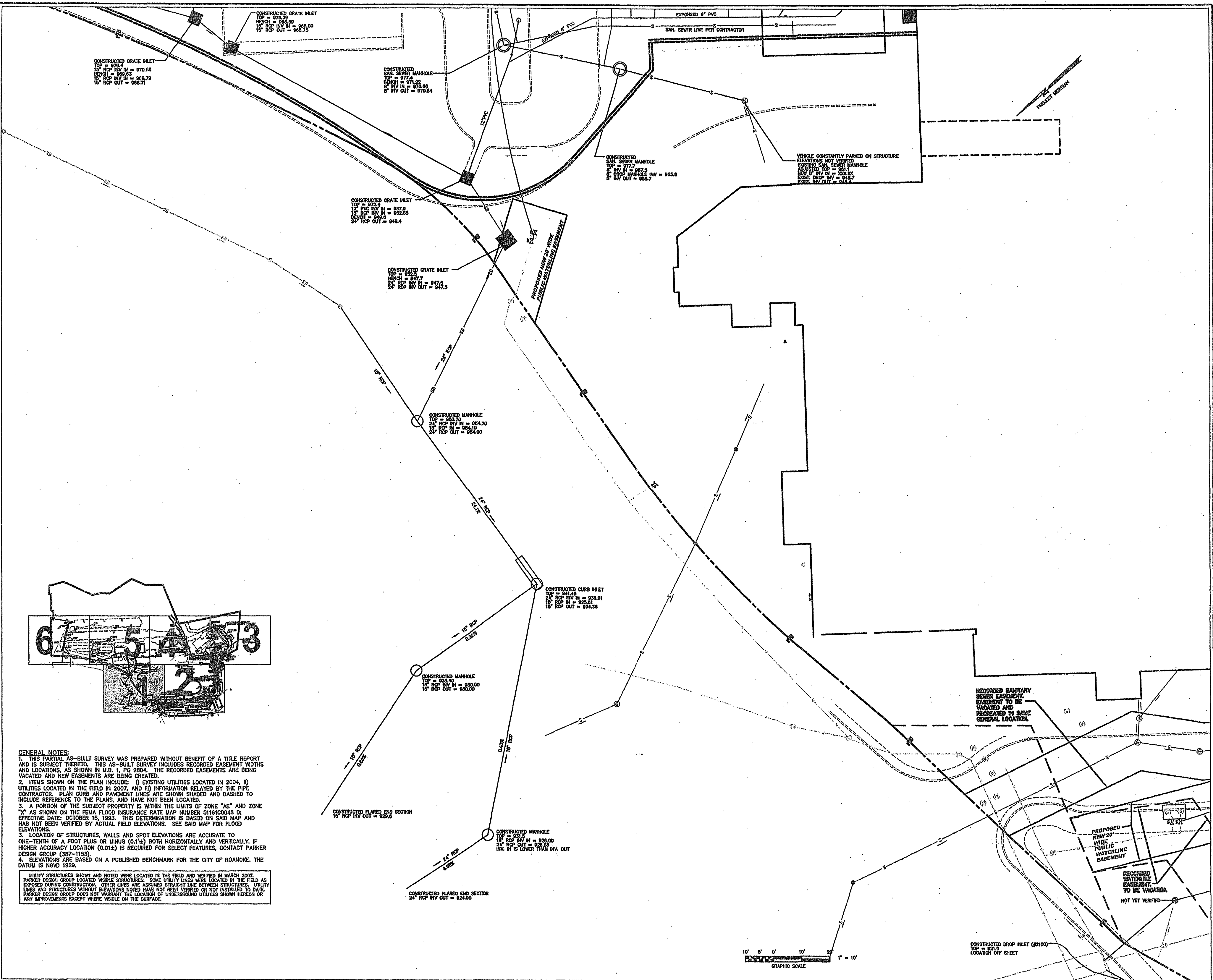

1. THIS PARTIAL AS-BUILT SURVEY WAS PREPARED WITHOUT BENEFIT OF A TITLE REPORT AND IS SUBJECT THERETO. THIS AS-BUILT SURVEY INCLUDES RECORDED EASEMENT WIDTHS AND LOCATIONS, AS SHOWN IN M.B. 1, PG 2804. THE RECORDED EASEMENTS ARE BEING VACATED AND NEW EASEMENTS ARE BEING CREATED.
2. ITEMS SHOWN ON THE PLAN INCLUDE: (i) EXISTING UTILITIES LOCATED IN 2004, (ii) UTILITIES LOCATED IN THE FIELD IN 2007, AND (iii) INFORMATION RELAYED BY THE PIPE CONTRACTOR. PLAN CURB AND PAVEMENT LINES ARE SHOWN SHADDED AND DASHED TO INCLUDE REFERENCE TO THE PLANS, AND HAVE NOT BEEN LOCATED.
