
GENERAL NOTES

GENERAL NOTES:

- 1. CONTRACTOR SHALL CALL "MISS UTILITY" AT 1-800-552-7001 AT LEAST 3 WORKING DAYS PRIOR TO ANY EARTHWORK ACTIVITY.
- 2. A PRE-CONSTRUCTION MEETING SHALL TAKE PLACE WITH RONAOKE COUNTY PRIOR TO BEGINNING CONSTRUCTION.
- 3. IT IS THE CONTRACTOR'S RESPONSIBILITY TO MEET COMPLIANCE REQUIREMENTS WITH SECTION 59.1-406, ET SEQ. OF THE CODE OF VIRGINIA (OVERHEAD HIGH VOLTAGE LINES SAFETY ACT).
- 4. THE CONTRACTOR SHALL BE RESPONSIBLE FOR OBTAINING ALL NECESSARY PERMITS BEFORE BEGINNING CONSTRUCTION.
- 5. ALL CONSTRUCTION WILL BE IN ACCORDANCE WITH ROANOKE COUNTY STANDARDS AND SPECIFICATIONS, AS WELL AS THE SPECIFICATIONS AS OUTLINED IN THE PROJECT MANUAL.
- 6. UNLESS SHOWN OR SPECIFIED OTHERWISE, METHODS AND MATERIALS SHALL BE IN ACCORDANCE WITH "VDOT ROAD AND BRIDGE STANDARDS" LATEST EDITIONS.
- 7. ANY NEW OR EXCAVATED EXISTING UTILITIES WILL BE VISUALLY INSPECTED BY THE COUNTY'S INSPECTOR PRIOR TO BACKFILLING TRENCHES.
- 8. ANY NEW UTILITIES TO BE MAINTAINED BY THE COUNTY SHALL BE WITHIN DEDICATED RIGHTS-OF-WAY OR EASEMENTS.
- 9. LOCATIONS OF UNDERGROUND UTILITIES AS INCLUDED HEREIN ARE APPROXIMATE, BASED ON AVAILABLE SURFACE STRUCTURES, SUCH AS VALVES, MANHOLES, ETC. AND RECORD INFORMATION. ENGINEER DOES NOT WARRANT THE EXISTENCE OF, OR LOCATION OF, UNDERGROUND UTILITY LINES AND/OR STRUCTURES. LOCATION OF WATERLINES AND SEWER LINES ARE BASED ON A SURVEY OF AVAILABLE INFORMATION ON FEBRUARY 3, 2006. CONTRACTOR SHALL VERIFY LOCATION OF ALL EXISTING UTILITIES PRIOR TO BEGINNING WORK AND SHALL BE RESPONSIBLE FOR REPAIR OF ANY UTILITIES DAMAGED AS A RESULT OF CONSTRUCTION
- 10. GARBAGE COLLECTION BY ON-SITE DUMPSTERS. TRASH SHALL NOT BE BURIED ON
- 11. CONTRACTOR SHALL SUBMIT SHOP DRAWINGS OF ALL DRAINAGE STRUCTURES TO ENGINEER FOR APPROVAL PRIOR TO CONSTRUCTION.
- 12. HORIZONTAL AND VERTICAL DATUM BASED ON INFORMATION PROVIDED BY OTHERS AS SHOWN ON SHEET C2.
- 13. ALL WORK SHALL CONFORM AND BE PERFORMED IN ACCORDANCE WITH FEDERAL, STATE, AND LOCAL REQUIREMENTS.
- 14. THE LOCATION OF ALL OFF-SITE FILL OR BORROW AREAS ASSOCIATED WITH THE CONSTRUCTION PROJECT WILL BE PROVIDED TO ROANOKE COUNTY DEPARTMENT OF COMMUNITY DEVELOPMENT. AN EROSION AND SEDIMENT CONTROL PLAN OR MEASURES MAY BE REQUIRED FOR THIS AREA.
- 15. CONSTRUCTION FIELD CHANGES SHALL NOT OCCUR WITHOUT APPROVAL OF THE CONSULTING ENGINEER AND ROANOKE COUNTY.
- 16. NEW ALIGNMENTS, CHANGES IN GRADES, ALTERNATIVE PIPE SIZES OR MANHOLES WILL REQUIRE A NEW SET OF PLANS STAMPED BY THE CONSULTING ENGINEER. COUNTY ENGINEERS WILL REVIEW PLANS WITHIN ONE DAY OF SUBMITTAL. PLAN SHEETS CAN BE 8.5X11 IF THE INFORMATION IS LEGIBLE.
- 17. APPROVAL OF SITE PLAN DOES NOT INCLUDE THE DESIGN OF THE FIRE SPRINKLER SYSTEM, UNDERGROUND PIPING FROM BACKFLOW PREVENTION DEVICE TO ONE FOOT ABOVE FINISHED FLOOR LEVEL. PRIOR TO INSTALLATION, SHOP DRAWINGS AND A SEPARATE PERMIT APPLICATION MUST BE SUBMITTED THROUGH THE DEPARTMENT OF BUILDING INSPECTIONS FOR REVIEW AND APPROVAL.
- 18. THE CONSTRUCTION MATERIALS AND METHODS USED FOR THIS PLAN SHALL CONFORM TO THE CURRENT VIRGINIA DEPARTMENT OF TRANSPORTATION ROAD AND BRIDGE SPECIFICATIONS.
- 19. ALL GRADING AND UTILITY CONSTRUCTION WITHIN THE RIGHT-OF-WAY MUST BE COMPLETED AND APPROVED BY THE COUNTY PRIOR TO INSTALLING THE FINAL
- 20. CONTRACTOR SHALL PROVIDE ADEQUATE COMPACTION AND TESTING ON EARTHWORK AS DIRECTED IN THE SPECIFICATIONS.
- 21. A SIGN PERMIT MUST BE OBTAINED PRIOR TO INSTALLATION OF ADDITIONAL SIGNAGE ON SITE. USE OF ADDITIONAL SIGNAGE SHALL CONFORM TO THE ROANOKE COUNTY ORDINANCE PER SECTION 30-93 OF THE ZONING ORDINANCE.
