GRAY BY DEED DATED JULY 27, 1987, AND RECORDED IN THE CLERK'S OFFICE OF THE CIRCUIT COURT OF ROANOKE COUNTY IN DEED BOOK 1273, PAGE 1583; AND BEING SUBJECT TO A LIEN OF A CERTAIN DEED OF TRUST MADE BY P-N-C, A NORTH CAROLINA GENERAL PARTNERSHIP, DATED OCTOBER 15, 1987 TO DANIEL F. LAYMAN, JR. AND FRANK W. ROGERS, JR., TRUSTEES, EITHER OF WHOM MAY ACT, SECURING A NOTE TO DOMINION BANK, NATIONAL ASSOCIATION, BENEFICIARIES.

THE SAID OWNER HEREBY DEDICATES TO AND VESTS IN THE CITY OF ROANOKE, VIRGINIA SUCH PORTIONS OF THE PREMISES AS PLATTED AS ARE ON THIS PLAT SET APART FOR WATER TRANSMISSION LINE EASEMENTS. 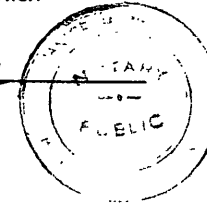
