PLANNED-UNIT DEVELOPMENT DISTRICT AS SET FORTH IN THE FRANKLIN COUNTY ORDINANCE.



6. APPLICANT WILL DEVELOP DOCKS AS SET FORTH IN THE CONCEPT PLAN. IN ADDITION, APPLICANT WILL ABIDE




