EROSION AND SEDIMENT CONTROL NARRATIVE PROJECT DESCRIPTION: THE PURPOSE OF THIS PROJECT IS FOR THE EXPANSION OF THE NEW HOPE CHRISTIAN CHURCH AND ASSOCIATED IMPROVEMENTS TO SERVE THIS USE. THE TWO POINTS OF ACCESS WILL BE FROM THE EXISTING PUBLIC RIGHT OF WAY OF WELCOME VALLEY ROAD. THE DISTURBED AREA FOR THE PROJECT IS ±4.46 ACRES. THE ESC MEASURES FOR THIS PROJECT WILL CONSIST OF TWO PHASES.

EXISTING SITE CONDITIONS: THE EXISTING SITE CONTAINS SEVERAL EXISTING BUILDINGS, ASPHALT PARKING LOT, AND OTHER MISCELLANEOUS IMPROVEMENTS. THE SITE GENERALLY DRAINS FROM NORTH TO SOUTH. A PORTION OF THE SITE DRAINAGE IS COLLECTED BY A SERIES OF STORM SEWER IMPROVEMENTS AND IS CONVEYED TO AN EXISTING STORMWATER DETENTION POND TO THE SOUTH. THE REMAINING DRAINAGE SHEET FLOWS OFF THE PROPERTY INTO THE EXISTING STORMWATER SYSTEM ALONG WELCOME VALLEY RD.

ADJACENT PROPERTY: THE PROPERTY IS BOUNDED TO THE NORTH BY RESIDENTIAL PROPERTY, EAST BY RECREATION AND OPEN SPACE, TO THE WEST BY INDUSTRIAL PROPERTY, AND TO THE SOUTH BY THE PUBLIC RIGHT OF WAY OF WELCOME VALLEY ROAD.

OFF-SITE AREAS: G.C. SHALL NOTIFY ROANOKE CITY OF THE LOCATION OF ANY OFF-SITE FILL OR BORROW AREAS PRIOR TO ANY MATERIAL BEING TRANSPORTED TO OR FROM THE SITE. CRITICAL EROSION AREAS: THE G.C SHALL ENSURE THAT NO SEDIMENT LADEN RUNOFF IS TRANSPORTED INTO THE EXISTING OR PROPOSED STORM SEWER SYSTEM. THE G.C.
