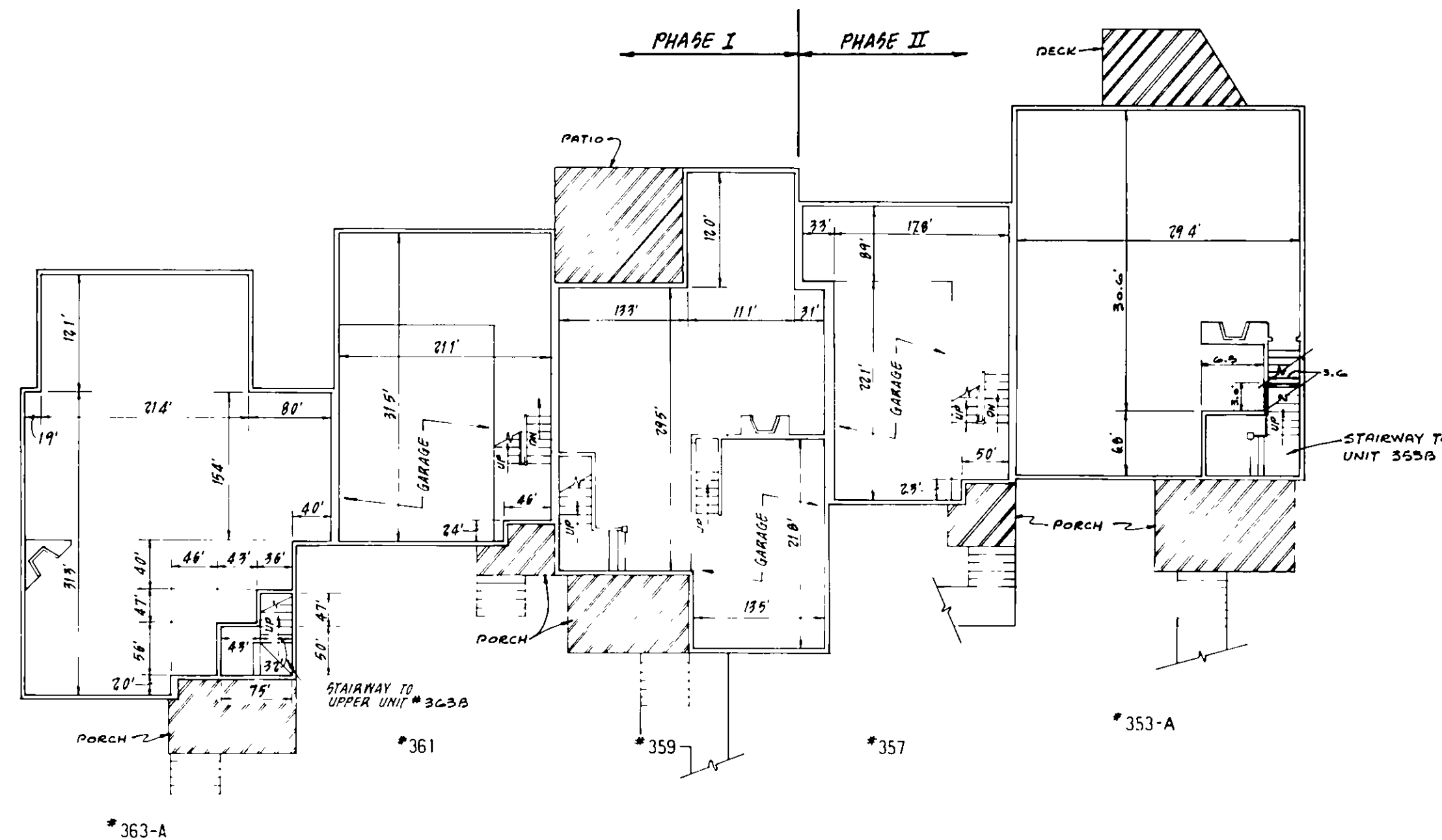




FIRST FLOOR PLAN

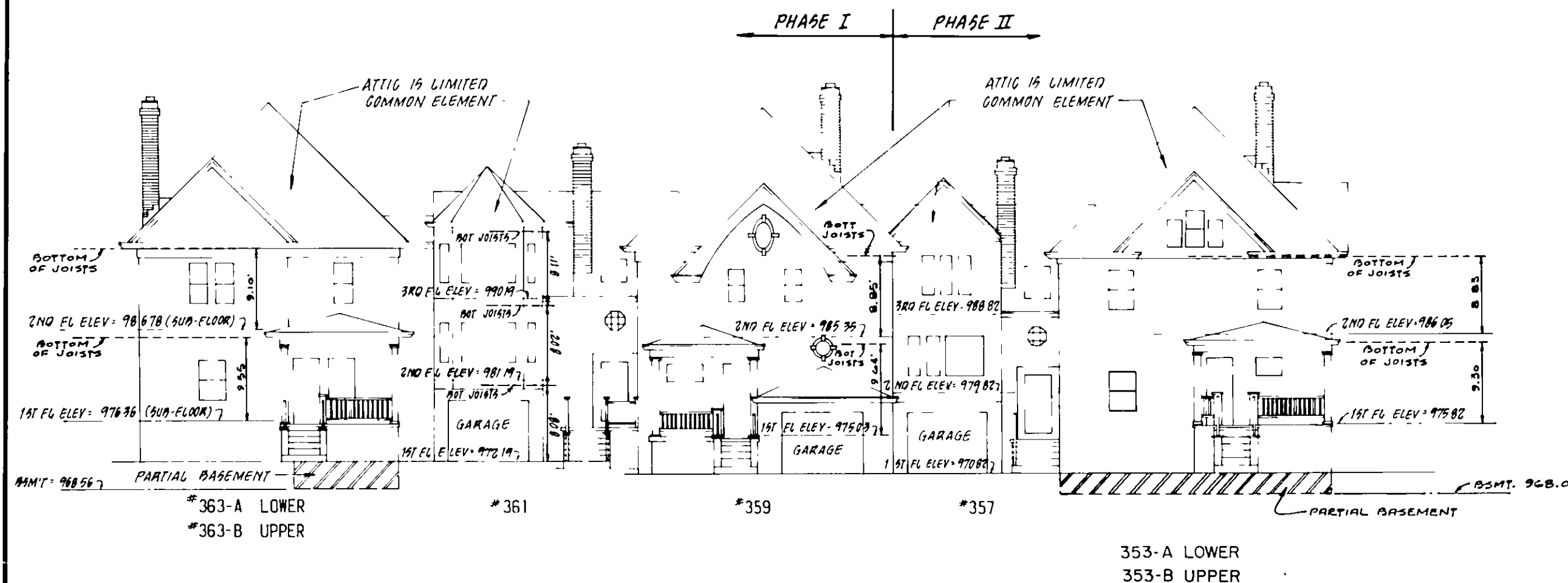

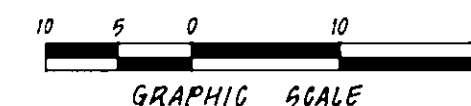
