- A PORTION OF THIS PROPERTY SURVEYED FALLS WITHIN THE ONE HUNDRED YEAR FLOOD PLAIN ALONG CARVINS CREEK IN THE VICINITY OF DENT ROAD. THE LIMITS OF THE 100 YEAR FLOOD PLAIN ARE BASED ON THE FIA FLOOD BOUNDARY MAP. THESE LIMITS SHOULD BE CONSIDERED APPROXIMATE. THE FIA MAPS HAVE NOT BEEN REVISED TO REFLECT THE GRADING ALONG THE CREEK ASSOCIATED WITH THE RECENT RUNWAY CONSTRUCTION.

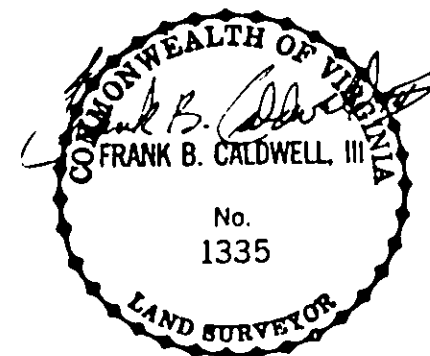
