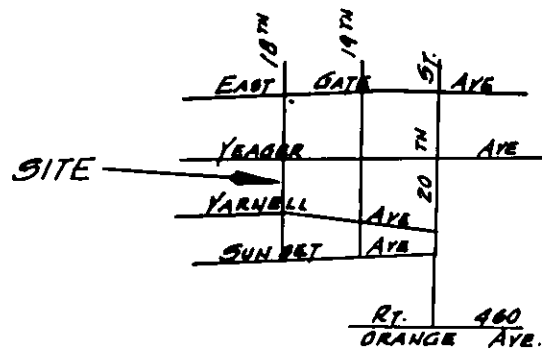
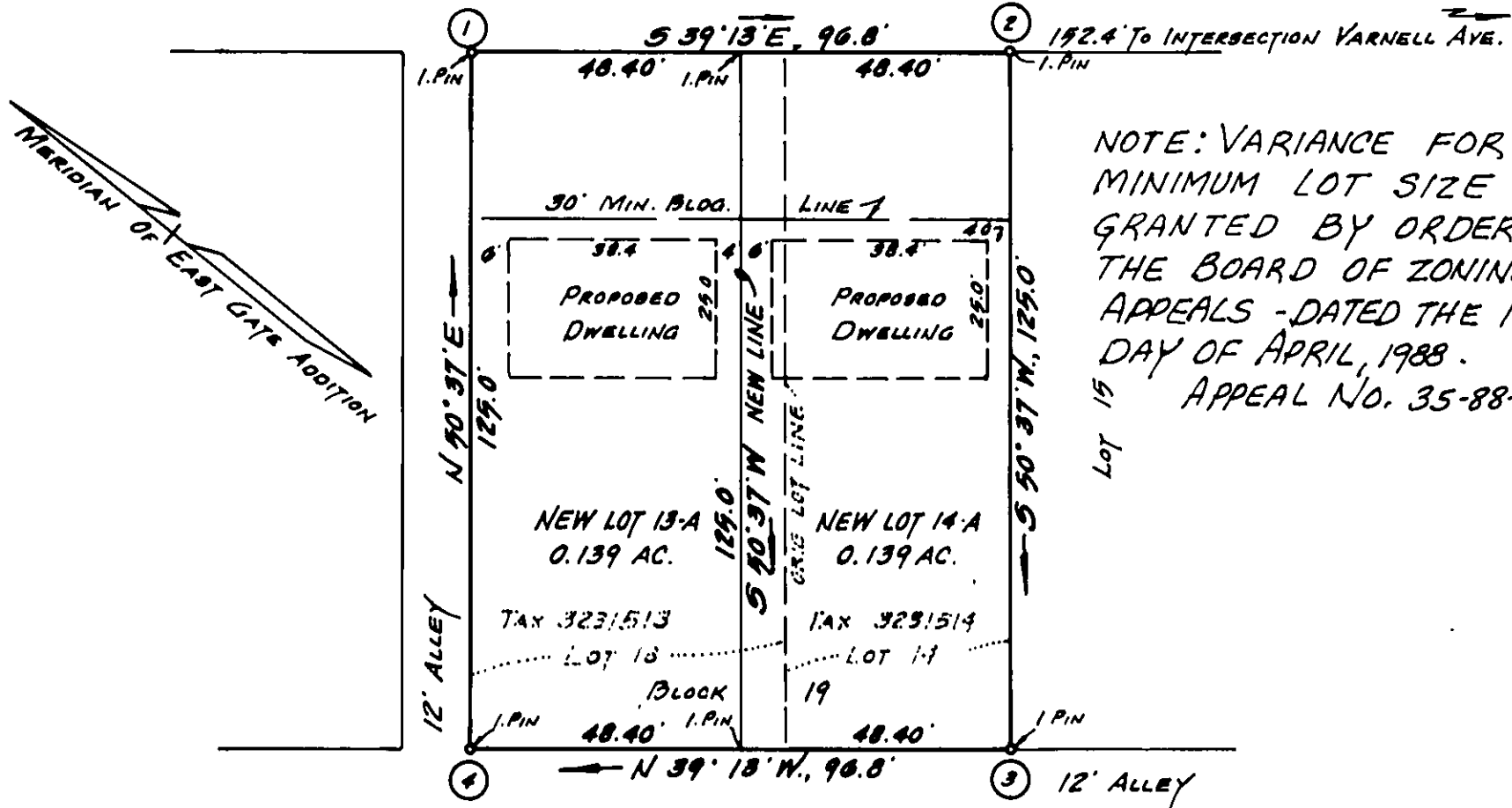


LOCATION MAP
