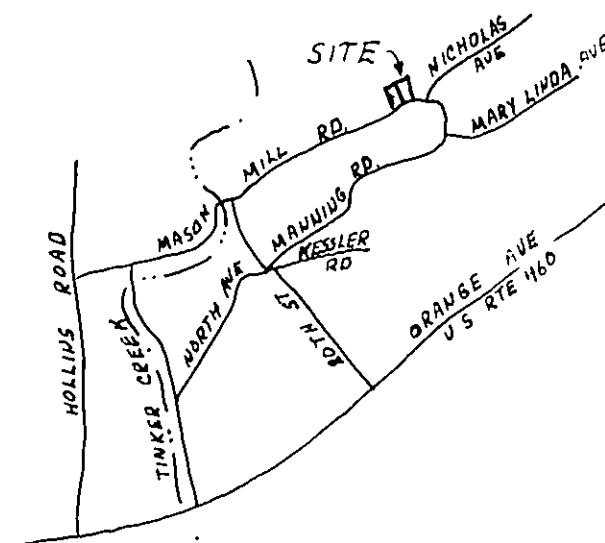

LOCATION MAP

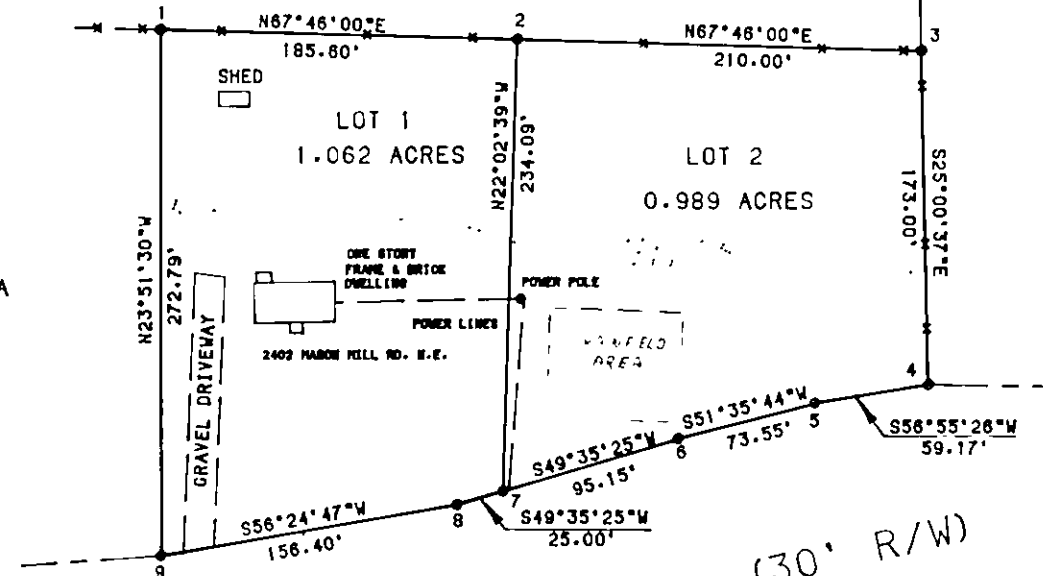

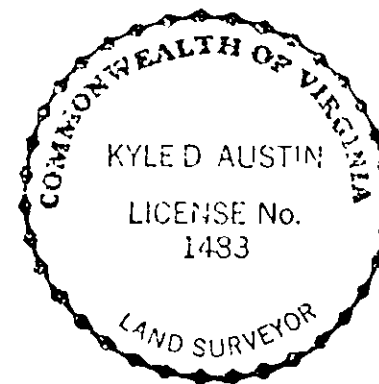


MASON MILL ROAD N.E. (30' R/W)
