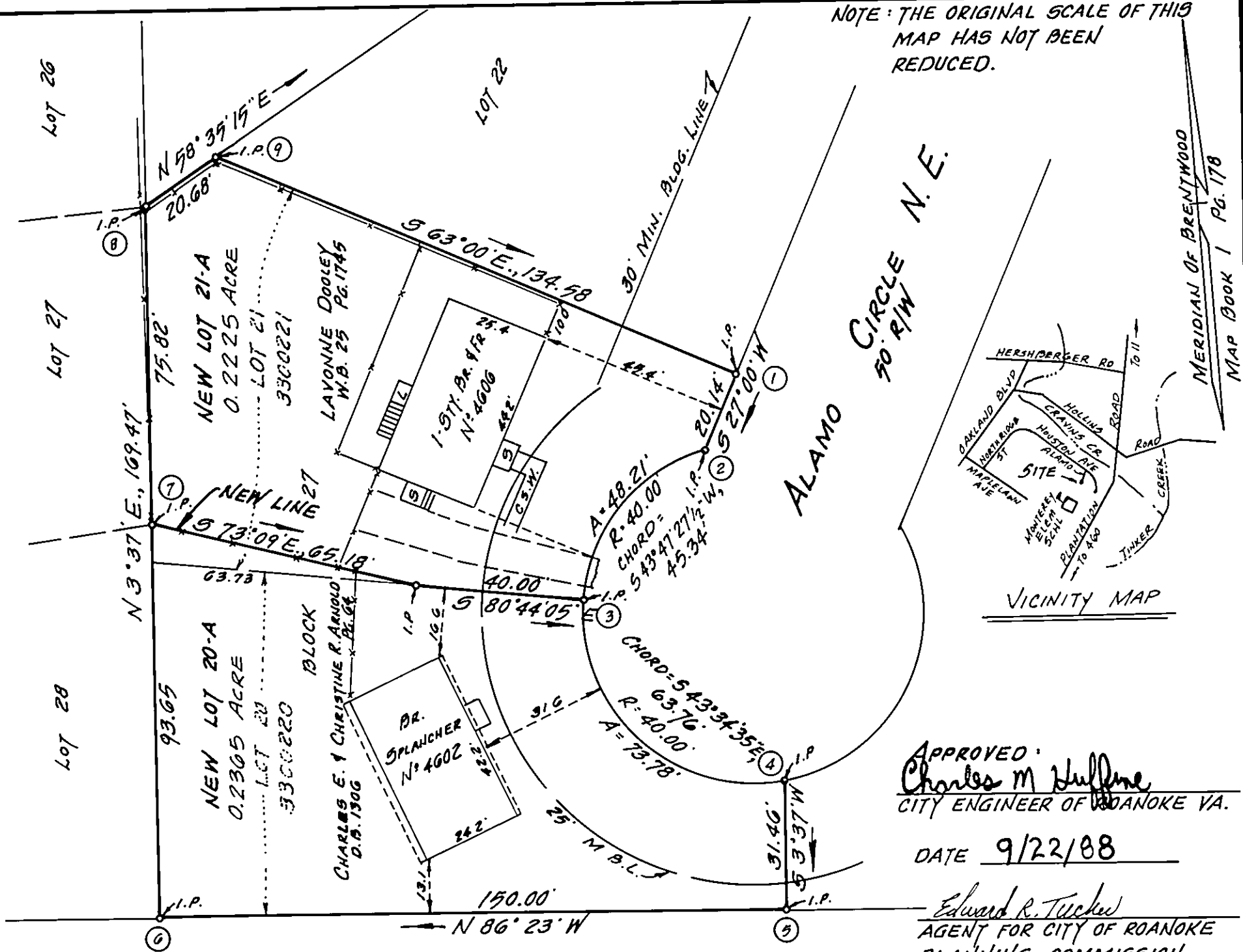


NOTE: THE ORIGINAL SCALE OF THIS MAP HAS NOT BEEN REDUCED.
