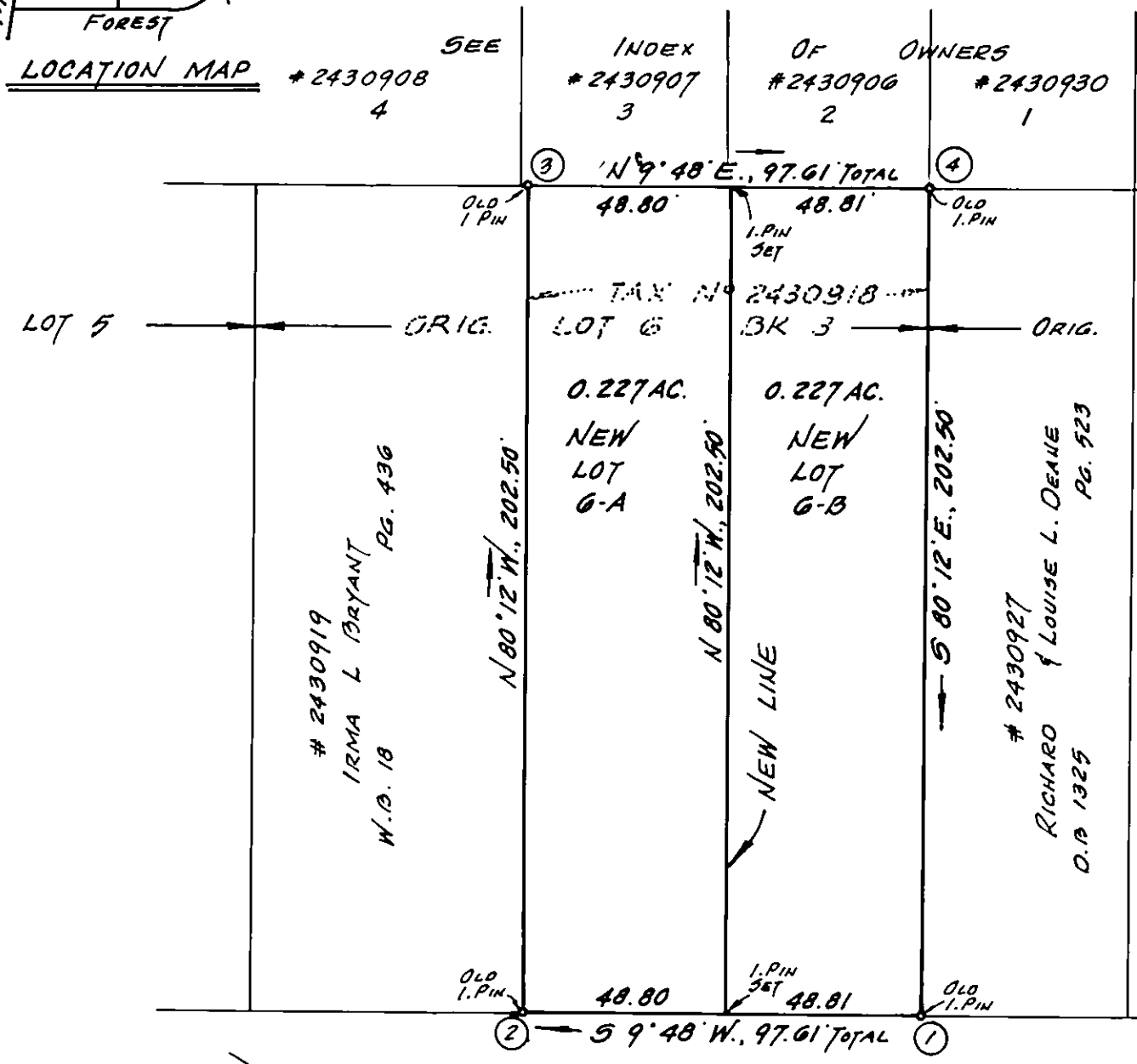


FOREST PARK CORP. MAP

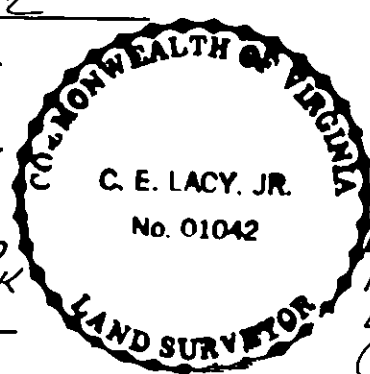
