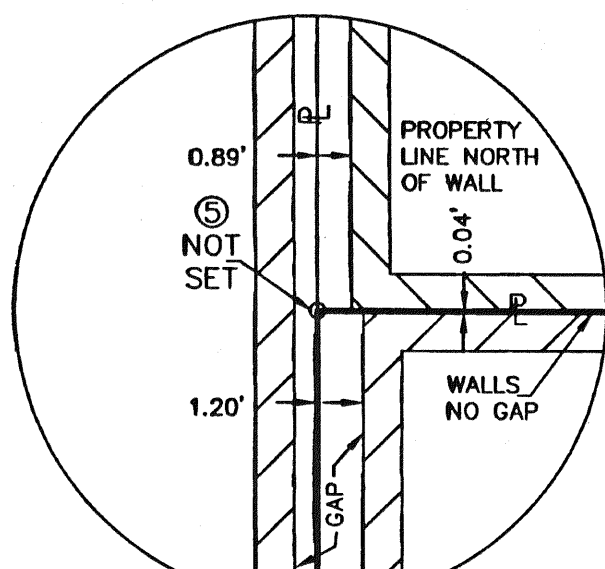

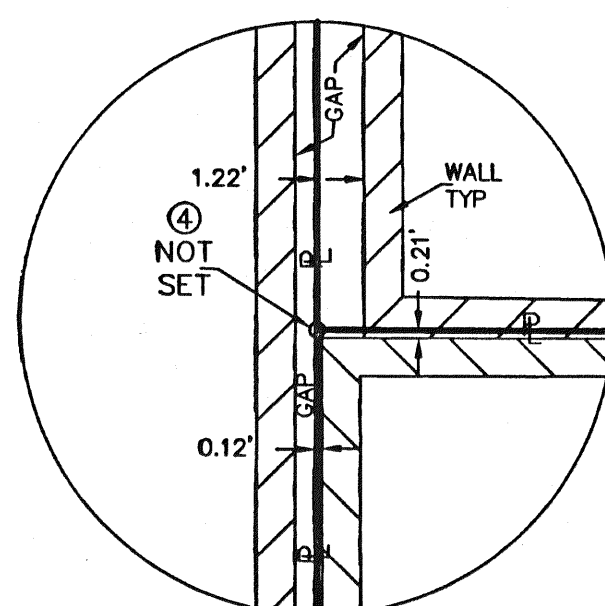
DETAIL CORNER #6

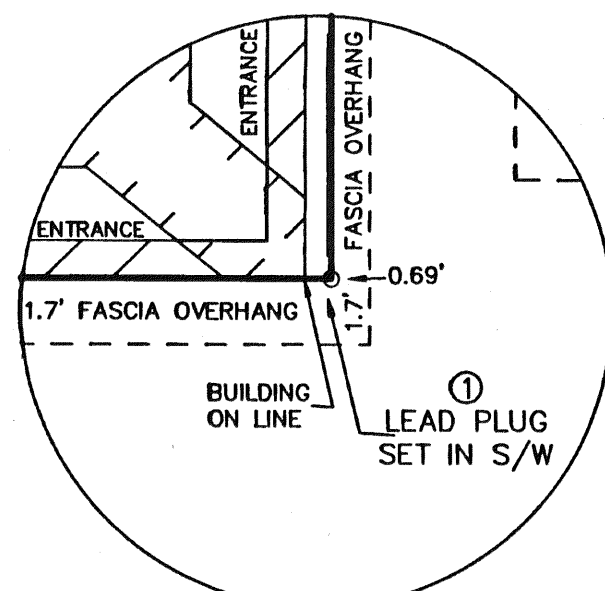
DETAIL CORNER #8

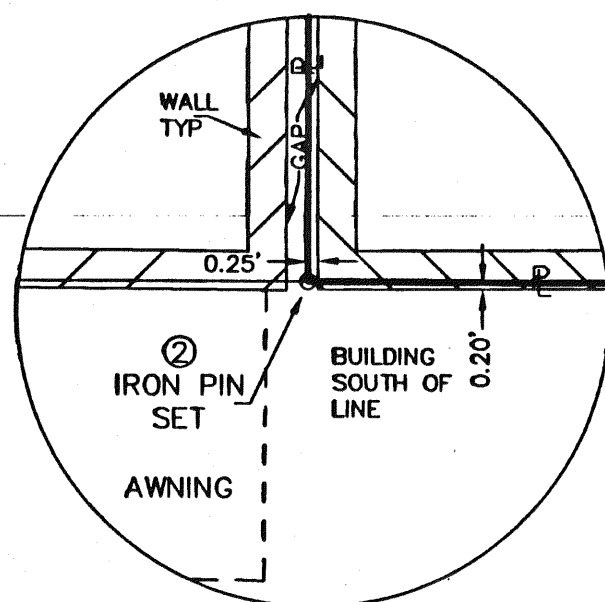

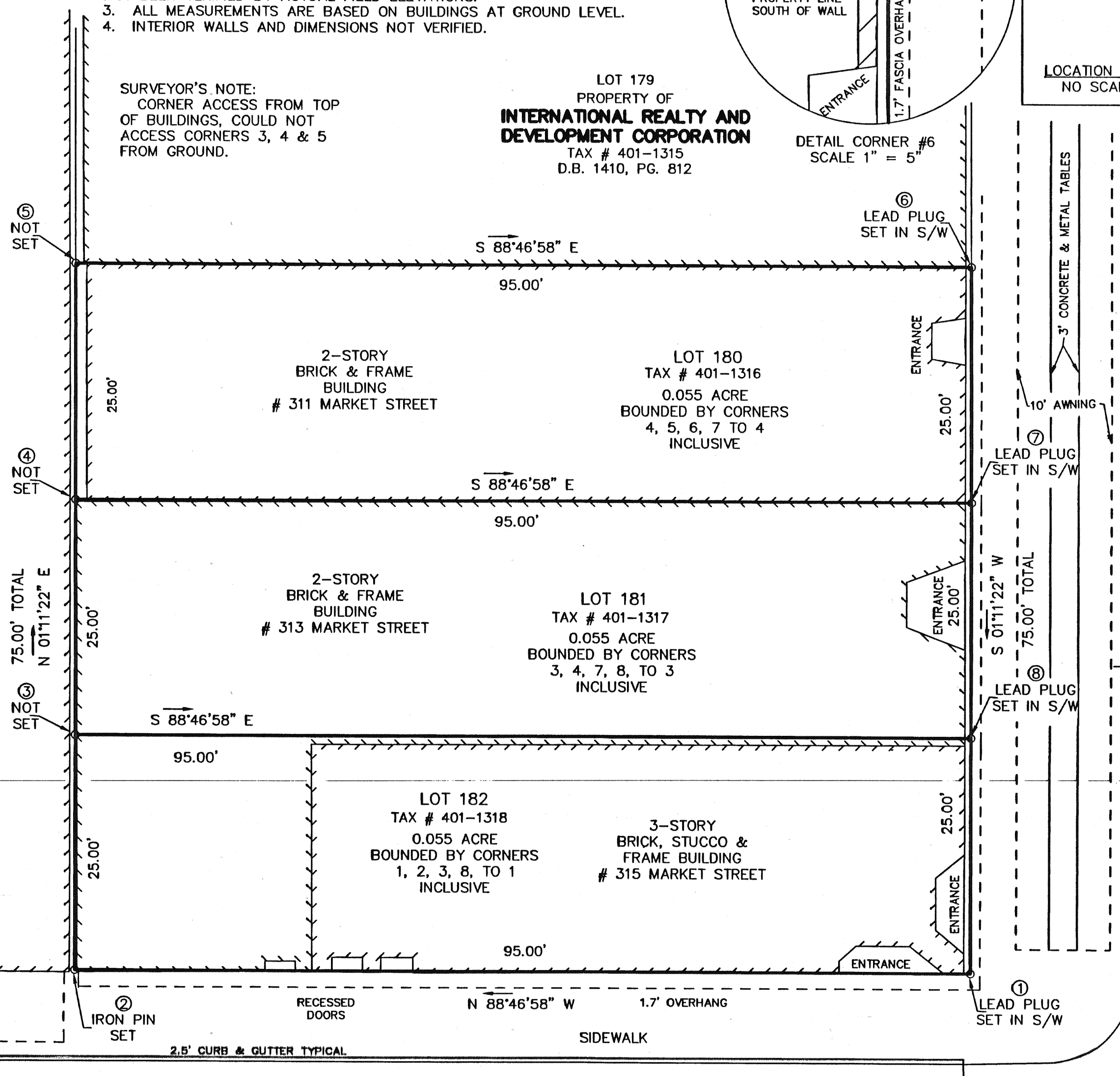
