Release and Imposition of Storm Water Control Facilities Maintenance Covenant:

By Maintenance Agreement dated March 11, 1987, recorded in the Clerk's Office of the Circuit Court of the City of Roanoke, Virginia, in Deed Book 1556, page 1739 ("the Maintenance Agreement"), the City of Roanoke imposed on all of the property of Towne Square Joint Venture, as shown on plat of subdivision of Towne Square recorded in said Clerk's Office in Plat Book 1, pages 589-92, certain obligations with respect to maintenance of storm water control facilities serving the Towne Square development. The 1.441-acre parcel, property of Sam's Real Estate Business Trust, which is to be conveyed to the Roanoke Regional Airport Commission and is becoming a part of new Parcel 7-A1 as shown hereon, was part of the original Towne Square development and is therefore subject to the covenants created by the Maintenance Agreement. New Parcel 7-A1 as hereby created will, however, have its own storm water control facilities and will not be a part of the Towne Square storm water control system.

Accordingly, the City of Roanoke, by its approval of this Subdivision and Combination Plat, releases the 1.441—acre parcel being conveyed by Sam's Real Estate Business Trust, to the Roanoke Regional Airport Commission, and becoming a part of new Parcel 7—A1, from the covenants and obligations imposed by the Maintenance

Conversely, the 1.802—acre parcel, property of the Roanoke Regional Airport Commission, which is to be conveyed to Sam's Real Estate Business Trust and is becoming a part of new parcel 10-A1 as shown hereon, will become part of the Towne Square development, will be served by the Towne Square storm water control facilities which are the subject of the Maintenance Agreement and must therefore be responsible, pro rata with the other property in Towne Square, for performance of the maintenance obligations described in the Maintenance Agreement.

Accordingly, Sam's Real Estate Business Trust, by its execution of this Subdivision and Combination Plat, agrees that the responsibility and obligation for maintenance of the Towne Square storm water control facilities, as those facilities and obligations are described in the Maintenance Agreement shall be a perpetual covenant which shall run with the title to the 1.802—acre parcel being acquired by Sam's Real Estate Business Trust from the Roanoke Regional Airport Commission and becoming a part of new parcel 10-A1 hereon, the same as if said parcel had been a part of the Towne Square development as originally described in the Maintenance Agreement.


