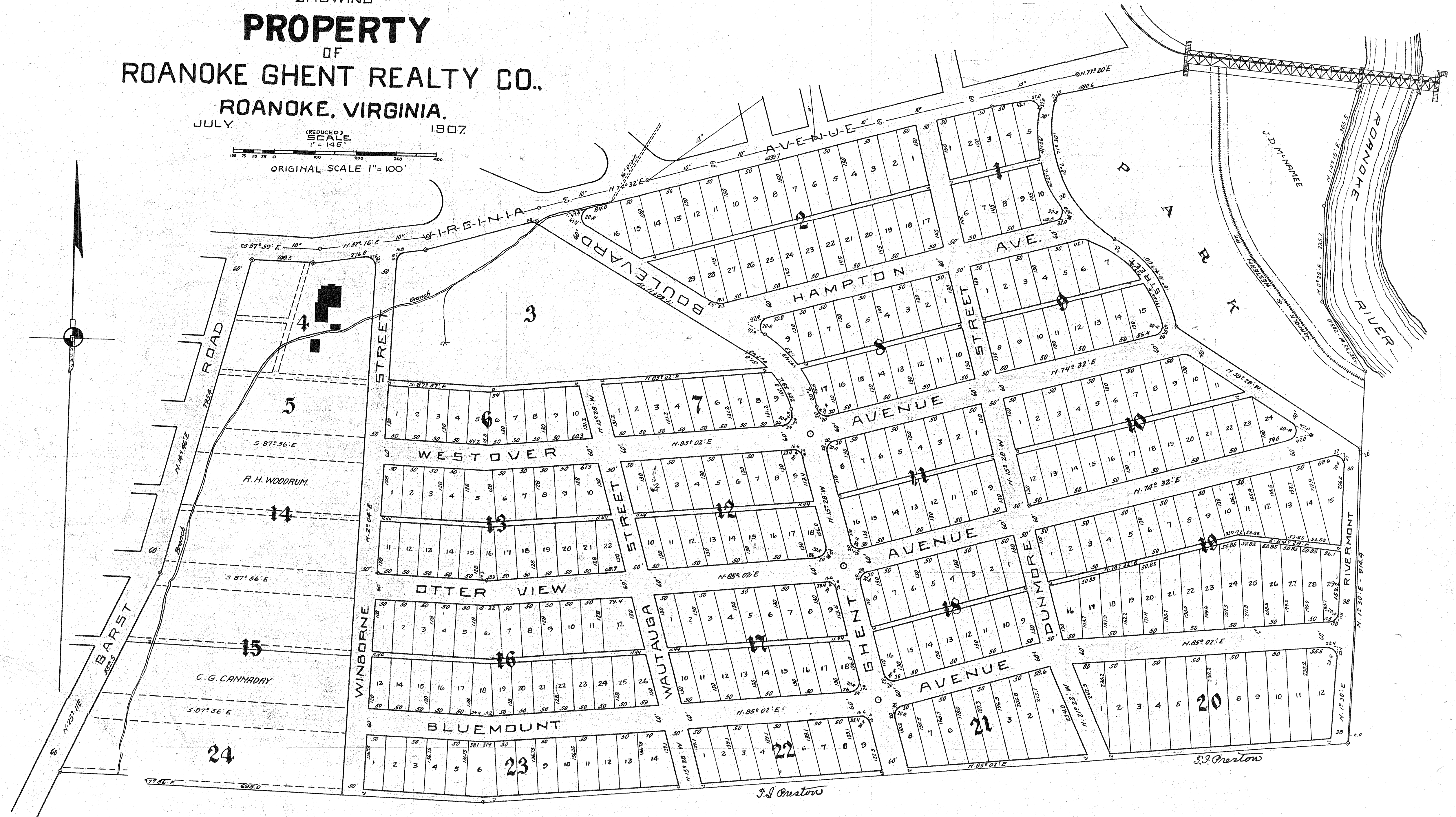


MAP

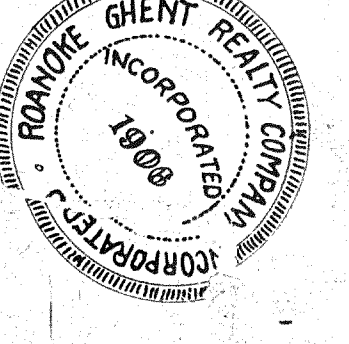
