

OFFICIAL MAP OF VINTON

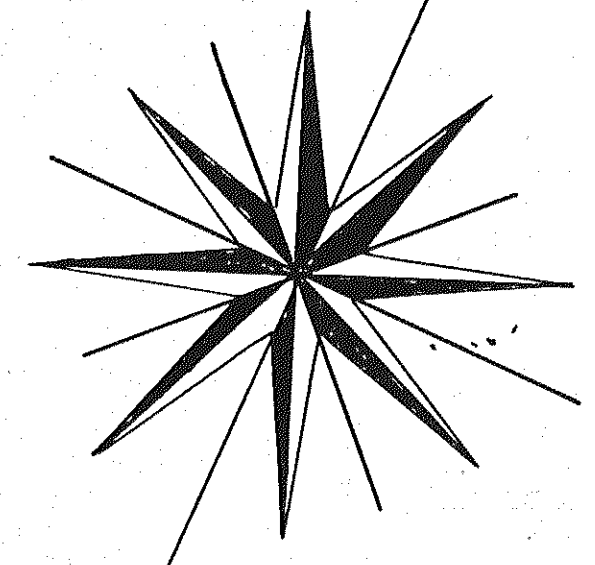

This agreement made this the 11th day of September 1911, by
F.R. Gish, J.H. Scott, S.M. Goggin, C.J. Gok, W.L. Wade, W.S. Pollard
and Gaston M. Gray, constituting Council of the town
of Vinton.

Witnesseth,

That the maps and various subdivisions, lots and tracts
of land within the corporate limits of the Town of Vinton,
as appear in the annexed plat, are directed to be
recorded in the Clerk's Office of Roanoke County, in the
map book kept in said Clerk's Office for said purposes,
as an Official map of said Town of Vinton, as per
actions by said Council at its regular meeting in
Sept. 1911, as appears of record in minute book
of said Town.
