


State of Virginia,

The above or foregoing subdivision of that certain tract or parcel of land lying in the County of Roanoke, Virginia, and known as Map number Two, of H.B. Nelms Addition, is bounded and described as follows: to wit:

Beginning at a stake on the West side of Garland Road, corner to the lands of Mrs. M.P. Cyphers; thence N. 55° 15' E., with the Cyphers line 491.8 feet to a stake; thence S. 78° E. with the said Cyphers line and that of Gray Lloyd 1566.8 feet to a white oak tree; thence with Brasellon Road S. 44° E. 1183 feet to a chestnut oak tree; thence along Gearheart Road N. 87° W. 1897.5 feet to a Spanish oak tree; thence S. 39° 14' W. 245.5 feet; thence N. 38° 46' W. 414.8 feet to a point; thence N. 6° W. 198 feet to a white oak on the South side of Garland Road; thence N. 25° 15' E. 33 feet crossing the road to a point; thence along the west side of said road S. 87° 45' E. 33 feet; thence N. 10° E. 44 feet; thence N. 12° 15' E. 49.5 feet; thence N. 4° 5' E. 39 feet; thence N. 43° W. 165 feet; thence N. 77° E. 99 feet; thence N. 21° W. 429 feet; thence N. 19° 15' W. 79.2 feet to place of Beginning. Variation of needle being about 1° 15' W.) and comprising 76 acres, 3 rods and 20 poles more or less, and being the same property conveyed to the said H.B. Nelms bearing date May 21st 1914 and of record in Deed Book 72 page 299, in the Clerk's Office of Roanoke County, of Salem, Virginia, and to which reference is hereby made for a fuller and more accurate description.
