


MAP OF

The annexed plot made by W. Lofton Smith, C.E. dated March 22<sup>nd</sup> 1924, showing the outside boundaries and sub-divisions of the tract or parcel of land, located in the County of Roanoke, Virginia and designated as Lots Belonging to John E. Buck, located in Eastgate is hereby adopted. The outside boundaries of said land being as follows: Beginning at the North West corner of said tract of land on Eastgate Ave, thence North 59 degs. 50' 07" feet to a point; thence South 59 degs. 50' 07" feet to a point; thence N. 59 degs. 50' 07" E. 144 feet to a point; thence N. 19 degs. 20' E. 63 feet to a point; thence N. 59 degs. 50' 07" E. 298.80 feet to a point; thence N. 0 degs. 15' W. 67.30 feet to a point; thence N. 3 degs. 0' E. 183.80 feet to a point; thence S. 54 degs. 30' E. 35 feet to a point; thence S. 49 degs. 00' E. 37 feet to a point; thence S. 27 degs. 29' E. 236.20 feet to a point; thence S. 62 degs. 15' W. 163.63 feet to a point; thence S. 30 degs. 10' E. 183.9 feet to a point on Walker Avenue; thence with Walker Ave. S. 53 degs. 50' W. 623.85 feet to a point on an alley; thence N. 30 degs. 10' W. 285.40 feet to the place of BEGGINING. The sub-division of said land as it appears on the annexed plot, is with the free consent and in accordance with the desire of the undersigned owner and proprietor.
