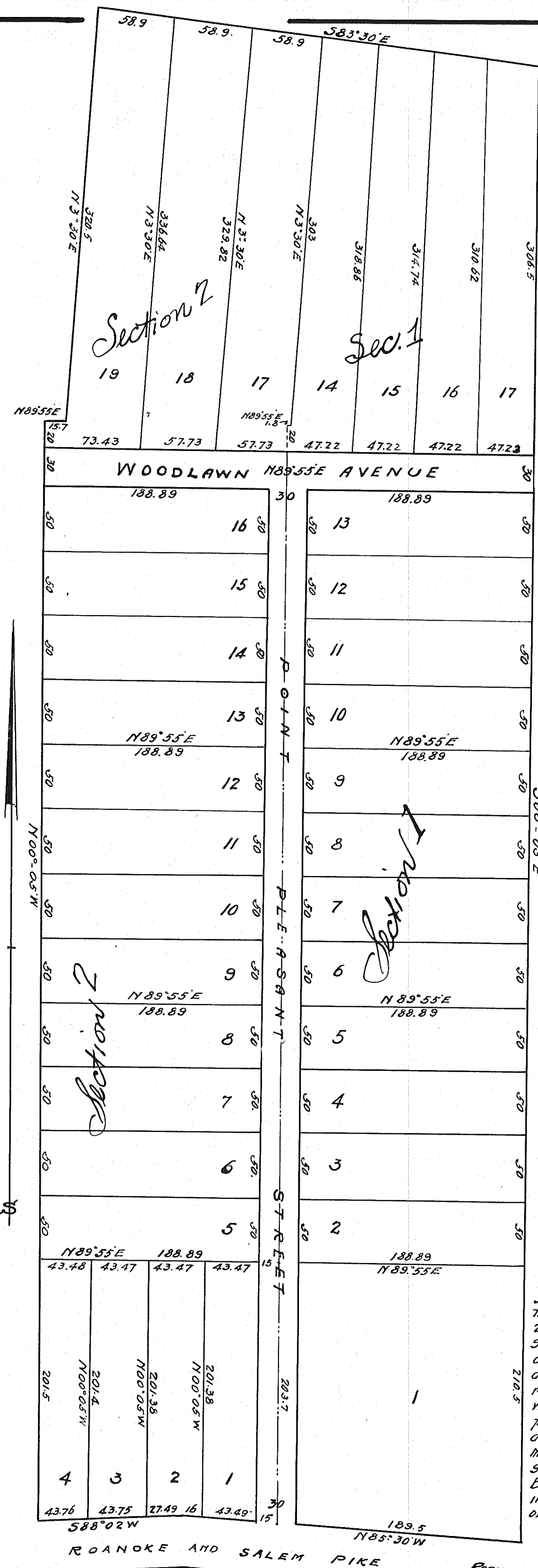


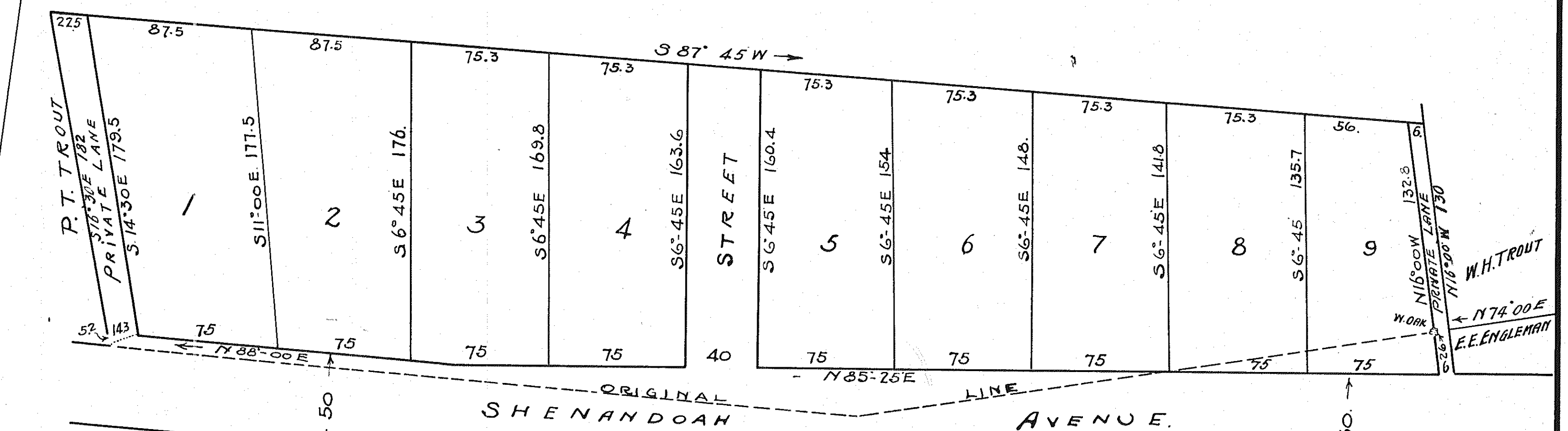


WESTWOOD

THE FOREGOING SUBDIVISION OF THE FOLLOWING PROPERTY

Beginning at a point on the North side of Roanoke and Salem Macadam Road, corner to M. McDaniel's line; thence along the North side of said road N. 85° 30' E. 264 feet to a point; thence still along said road S. 85° 02' W. 115 feet to a point on said road; thence N. 00° 00' degs. 05 min. W. 251.5 feet to a point; thence N. 89° 55' E. 157 feet to a point; thence N. 3 degs. 30 min. E. 320.5 feet to a point on the outside line; thence with outside line S. 83 degs. 30 min. E. 365.4 feet to a point stake; thence S. 0 degs. 05 min. E. 1147 feet to a post corner to M. McDaniel's lot on the North side of Macadam Road, the place of Beginning, and containing 3.92 acres of land, as it appears by this plot called Bellview Park Addition is with the free consent and in accordance with the desire of the undersigned owners and proprietors.

Engleman, thence S. 16 degs 30' E. 182 feet to a stake; thence S. 87° 45' W. 751.5 to a stake on W.H. Trout's line; thence with said line N. 16 deg. 00 min W. 130 to a stake on the South side of Shenandoah Avenue; thence with said avenue N. 83 deg 25 min. E. 571 feet to a stake; thence N. 88 deg 00 min E. 165 feet to the place of beginning, and containing about three acres.
