

Further certifying that this plot is with the free concert and in accordance with the desire of the undersigned owners as shown by the duly authorized signature hereto of its President and Secretary, reserving, however, all rights, uses and easements in and to said streets and avenues, except the public easement and right of passage to the public thoroughfare and State highways of the Commonwealth of Virginia.
