

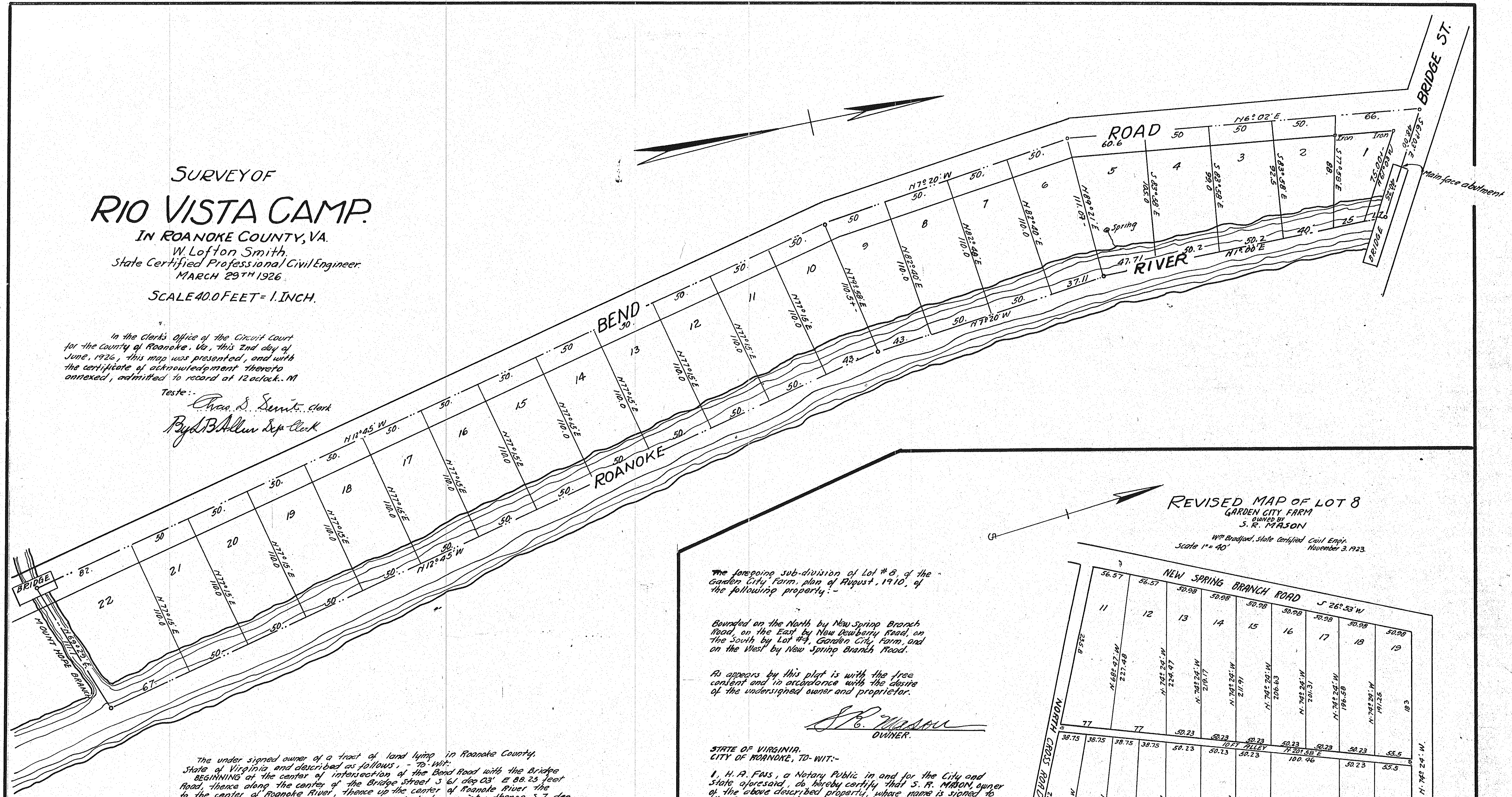
SURVEY OF RIO VISTA CAMP.

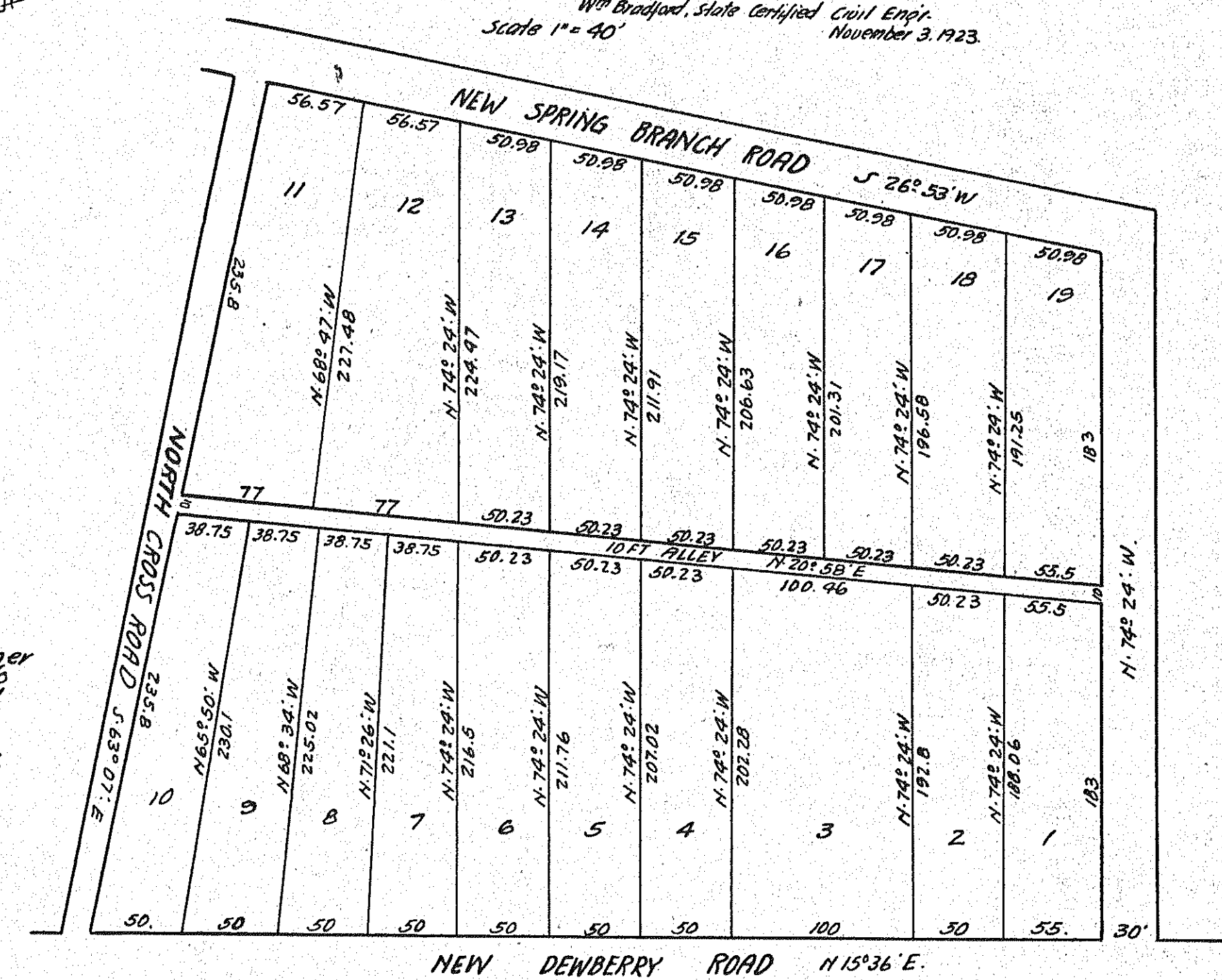
