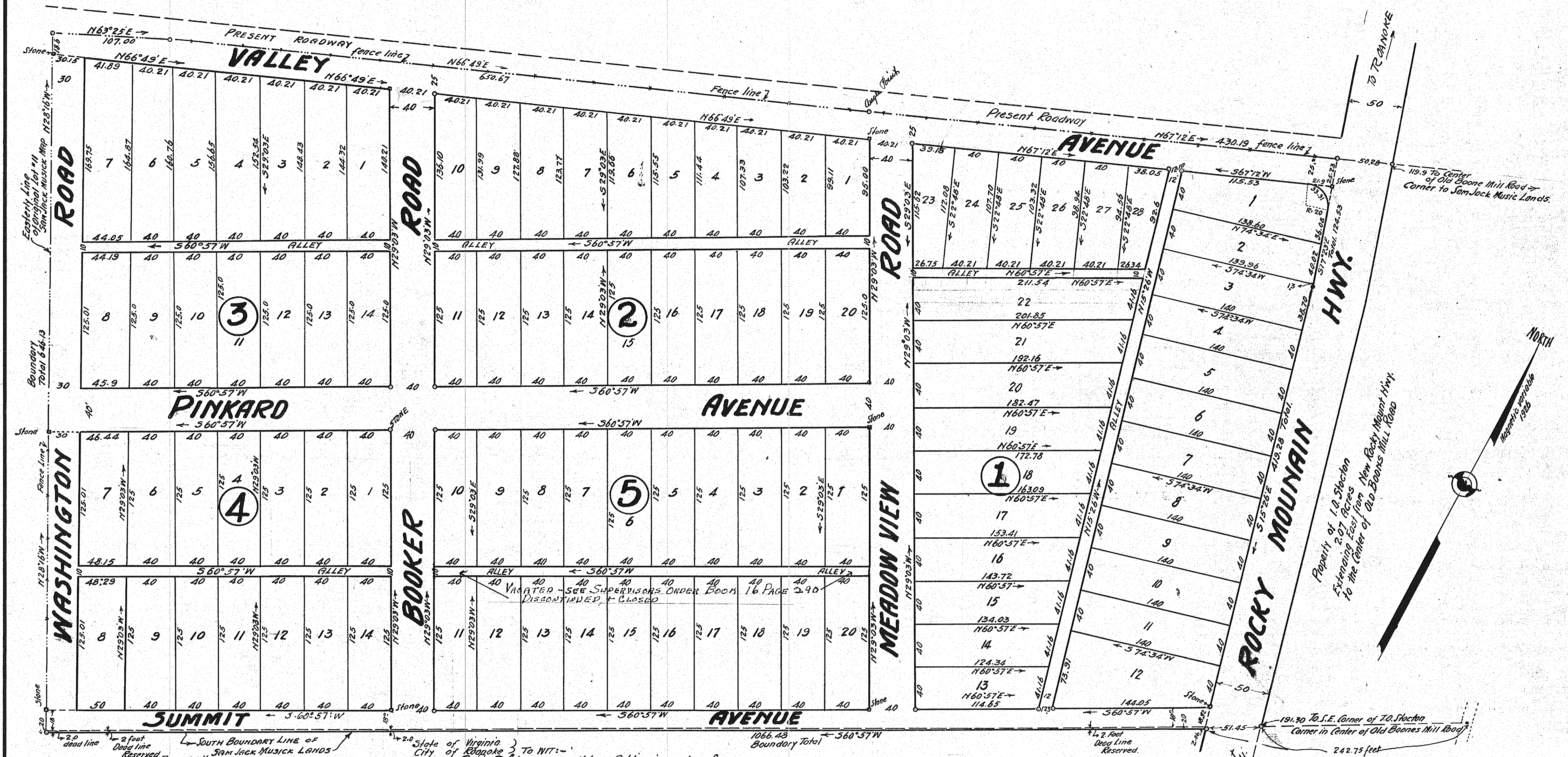




The annexed plat made by C. B. Malcolm, State Certified Engineer, dated April 16, 1926, and showing the outside boundaries and the subdivision of the tract, or parcel of land, located in Roanoke County, Virginia, and designated as PINKARD COURT, is hereby adopted. The outside boundaries of said land being as follows, to wit:-

BEGINNING at a point of intersection of the southerly line of the original San Jack Musick lands with the present right of way line of the new Rocky Mount Highway said beginning point being S. 60 Deg. 57' W. 242.75 feet from the original southeast corner of San Jack Musick lands which was located in the center of the old Boone Mill road; thence along the southern boundary line of San Jack Musick lands, S. 60 Deg. 57' W. 1066.48 feet to southeast corner of lot 11, as shown on sub-division of the San Jack Musick map; thence along the easterly line of said original lot 11, N. 28 Deg. 15' W. 646.13 feet to a point in Valley Avenue; thence along same, the following three courses and distances, N. 63 Deg. 25' E. 107 feet; N. 66 Deg. 49' E. 650.67 feet; N. 67 Deg. 12' E. 430.19 feet to a point on west side of Rocky Mount Highway; thence along same S. 17 Deg. 23' E. 124.53 feet to a point; thence S. 15 Deg. 26' E. 419.28 feet to the place of beginning.

That the subdivision of said land as appears on the annexed plat is with the free consent and in accordance with the desire of the undersigned owner and proprietor. Given under my hand and seal, this 19th day of July, 1926.
