

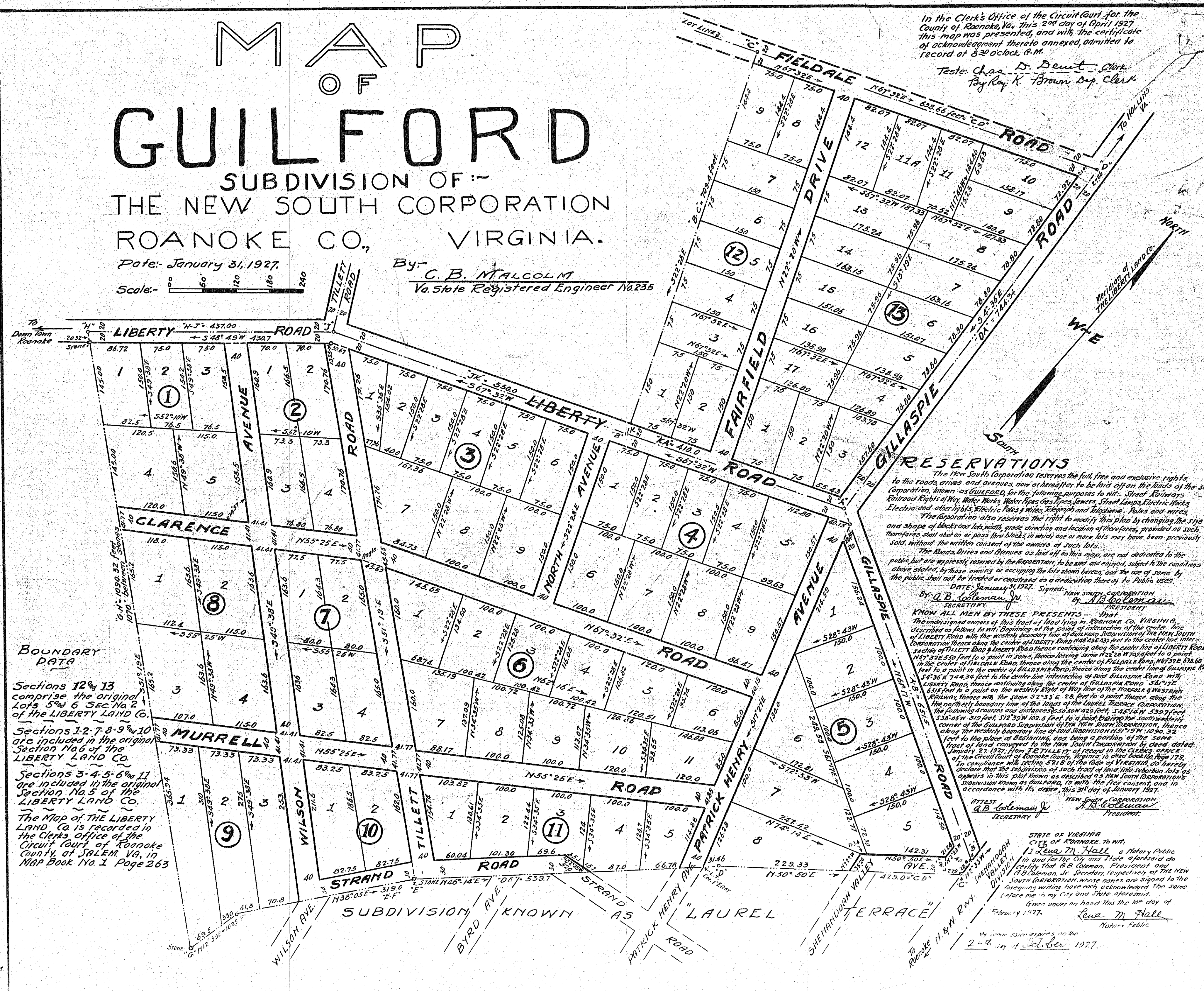
MAP OF GUILFORD

RESERVATIONS

The New South Corporation reserves the full, free and exclusive rights, to the roads, drives and avenues, now or hereafter to be laid off on the lands of the said Corporation, known as GUILFORD, for the following purposes to wit: Street Railways, Railroad Rights of Way, Water Pipes, Gas Pipes, Sewer Pipes, Electric Lines, Electric and other light, Electric Poles, Wires, Telegraph and Telephone. Poles and wires and other appurtenances necessary for the use of the same.

The Corporation also reserves the right to modify this plan by changing the size and shape of blocks and lots, width, grade, direction and location of thoroughfares, provided no such modification shall affect or pass through blocks in which one or more lots may have been previously sold, without the written consent of the owners of such lots.

The Roads, Drives and Avenues as laid off on this map, are not dedicated to the public, but are expressly reserved by the Corporation, to be used and enjoyed, subject to the conditions above stated, by those owning or occupying the lots shown hereon, and the use of same by the public shall not be treated or construed as a dedication thereof to Public uses.
