DESCRIPTION

Beginning at a point on the north side of the Lee Highway, Beginning at a point on the north side of the Lee Highway, corner to the County Farm and running thence with a line of the County Farm, the center line of a thirty foot road, N21°53'W 1438.5 feet to an iron pipe, corner to the County Farm; thence 5 66° 40'W - 371.2 feet to a large dead Chestnut, corner to the land of J.P. Sutphin; thence with his line, S21°53'E - 1459.8 feet to an iron pipe on the north side of the Lee Highway, corner to the land of J.P. Sutphin; thence along the north side of the Lee Highway, N 63°22'E - 372.0 feet to the beginning, containing twelve and thirty-three hundredths (12.33) acres.

CERTIFICATE OF THE OWNER

No dwelling, or other structure, costing less than \$2500. shall be erected on Lots 1, 2, and 3, as shown on said plat; nor shall any building erected on any of the other lots of the said plat cost less than \$1250, necessary out-buildings excepted. Upon a breach of any one or more of the foregoing restrictions within a period of twenty years from the date of this plat the property thus involved shall immediately revert to, and title thereto vest in, the undersigned, his heirs, executors, or assigns.
