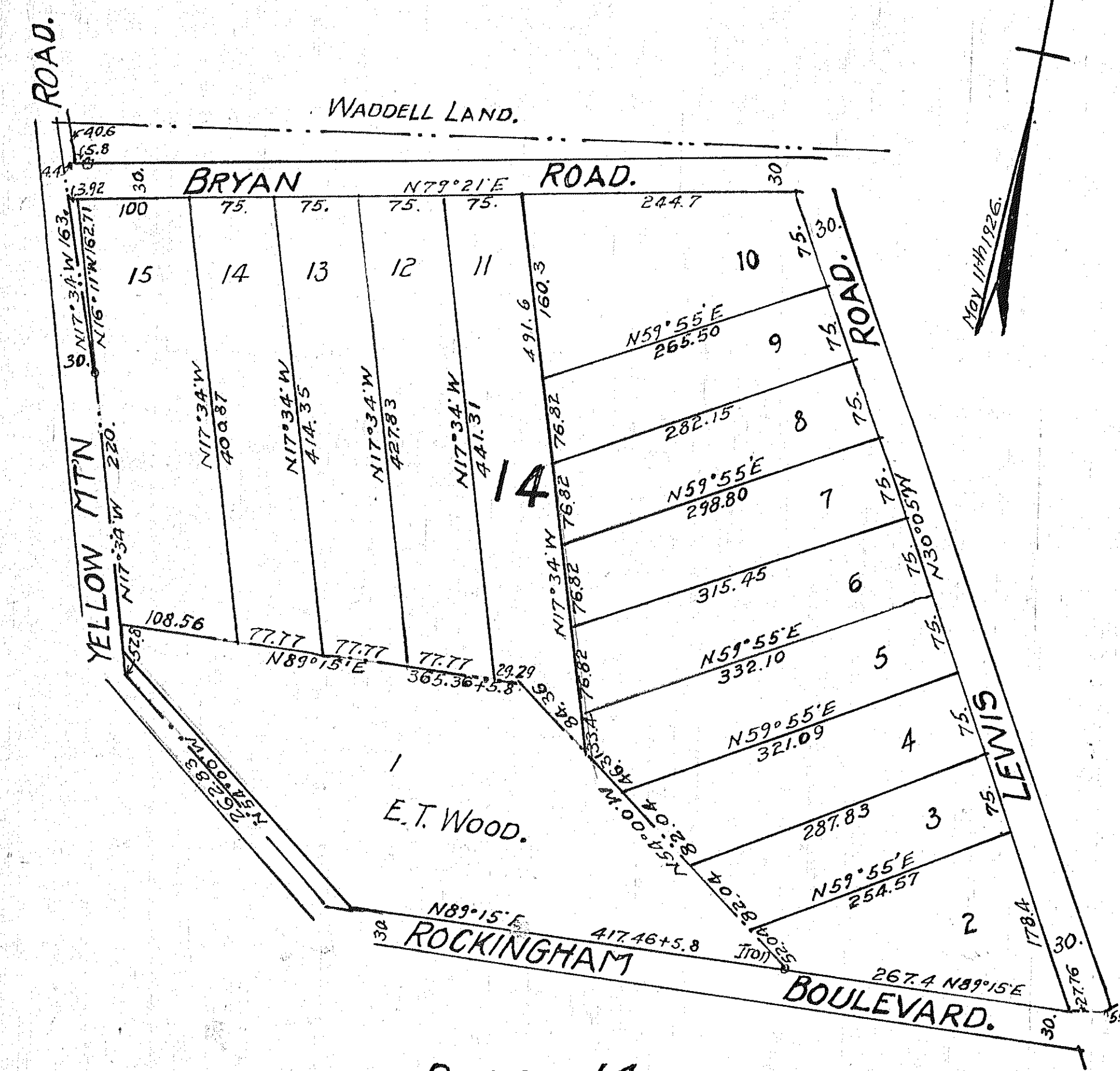




BLOCK 14

The undersigned owner of a tract of land in Roanoke County, Virginia, and discribed as follows: Beginning at the south east corner of the Yellow Mountain Road and the Bryan Road, thence along the southerly side of the Bryan Road N79°21'E 644.7 feet the a corner of the Lewis Road, thence along the westerly side of the Lewis Road S30°05'E 778.4 feet to a corner of Rockingham Boulevard thence along the northerly side of Rockingham Boulevard S89°15'W 690.66 feet to the center line of the Yellow Mountain Road, thence along the center line of the Yellow Mountain Road N54°00'W 262.83 feet to the easterly side of the Yellow Mountain Road as a proposed change in the Road, thence along the easterly side of the proposed change in the Yellow Mountain Road N17°34'W 435.8 feet to a point partly in the Yellow Mountain Road, thence N79°21'E 392 feet to the place of Beginning, and containing, approximately, 10.5 acres; does, in accordance with Section 5218, Code of Virginia, hereby Certify that the sub-Division as shown by this plat is with my free will and Consent, this 12th day of September 1929.
