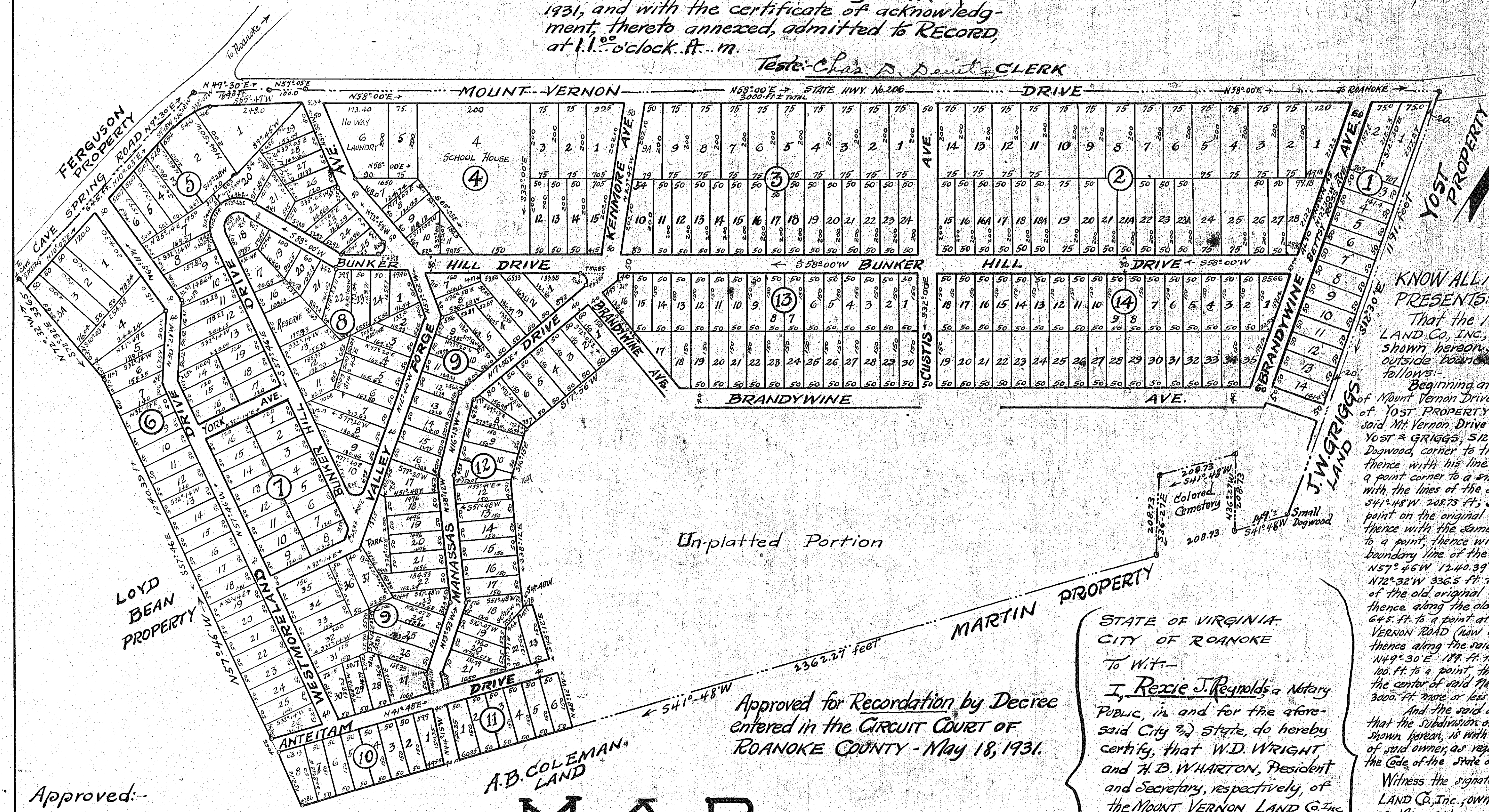


In the Clerk's Office of the Circuit Court,

That the MOUNT VERNON
LAND CO., INC., owner of the land
shown hereon, certifies that the
outside boundary lines are as

of Mount Vernon Drive, corner to the property
of YOST PROPERTY, thence leaving the
said Mt. Vernon Drive and with the line of

Dogwood, corner to the land of "MARTIN"
thence with his line, S41°48'W 149 ft. to
