

KNOW ALL MEN BY THESE PRESENTS: That W.C. Burns, was at the time the attached map was made, to wit: Feb. 4, 1916, the owner of the tract of land hereon shown, known as SPRING GROVE, which land is bounded as follows: Beginning at a point in the center of the BEDFORD ROAD, corner to the land of C.L. BUSH, thence leaving the said BEDFORD ROAD, and with the westerly boundary line of the lands of BUSH and MUSE, N13°22'W, 3873.87 feet to a point in the center of the Water Co ROAD, thence along the center of said Road, and with the south line of the land of Alice S. Hutchins, 57°40'W 699.5 ft to a point; thence S88°10'W, 100 ft; thence S89°40'W 418.4 ft; thence S30°45'W 410 ft; thence S1°30'W 325 ft; thence leaving the said Road, S56°18'E 72 ft to a point; thence with the BUSH Line S7°30'W 2635.2 ft; thence S64°48'E, 1650 ft to a point in the center of the BEDFORD ROAD, thence along the center of the same N72°12'E 469.8 ft; N63°42'E 727.13 ft to the Place of Beginning. The said W.C. BURNS, the then owner of said tract of land, certifies that he then caused the same to be subdivided into suburban lots as shown hereon, entirely with his free will and consent, and from time to time, sold the lots or parcels of land as shown hereon, making reference thereto, but by oversight, this map was not recorded, and he doth now execute this Certificate for the purpose of permitting the Recordation of said Map.
