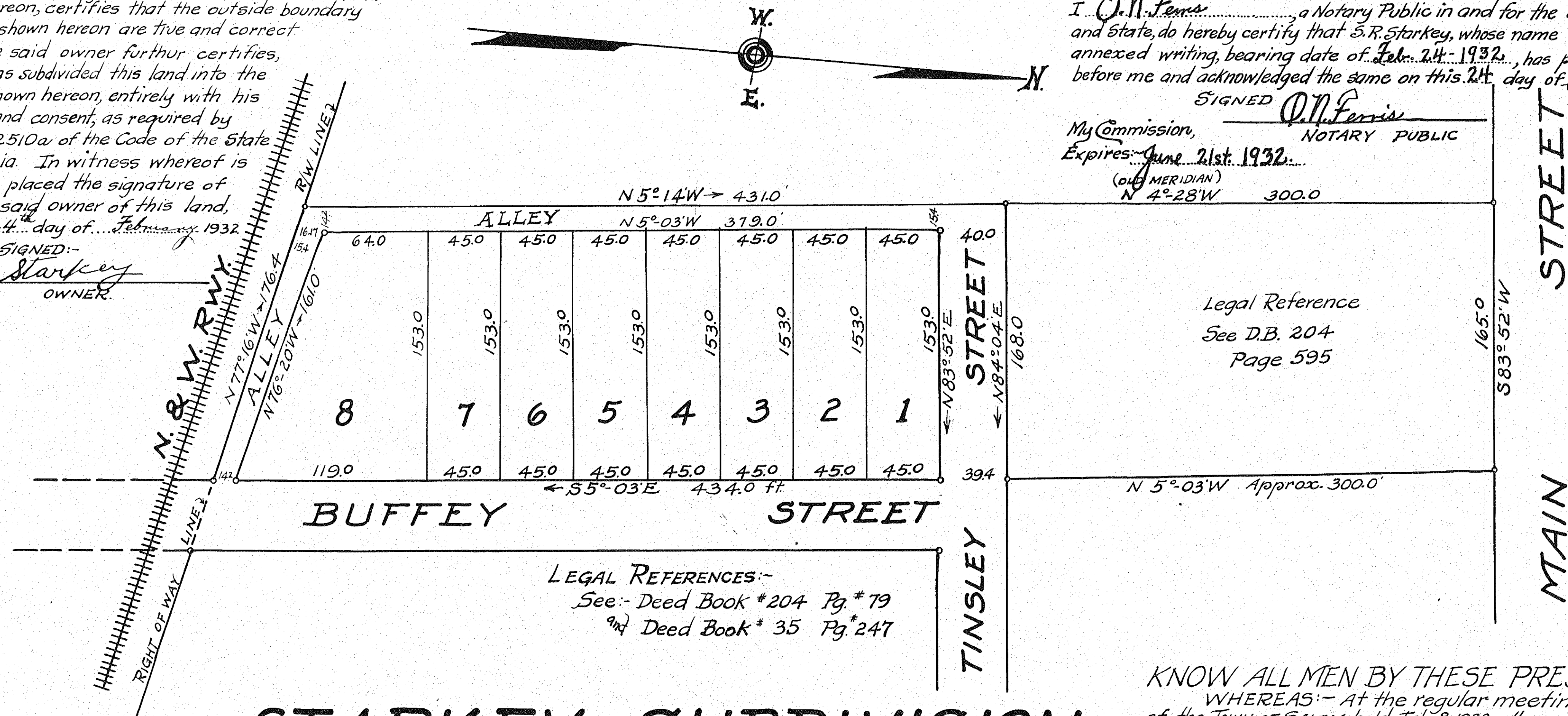

KNOW ALL MEN BY THESE PRESENTS To Wit
WHEREAS:- At the regular meeting of the COUNCIL of the TOWN OF SALEM, held Feb. 8, 1932, all members being present, on motion the following ordinance was unanimously adopted:-
