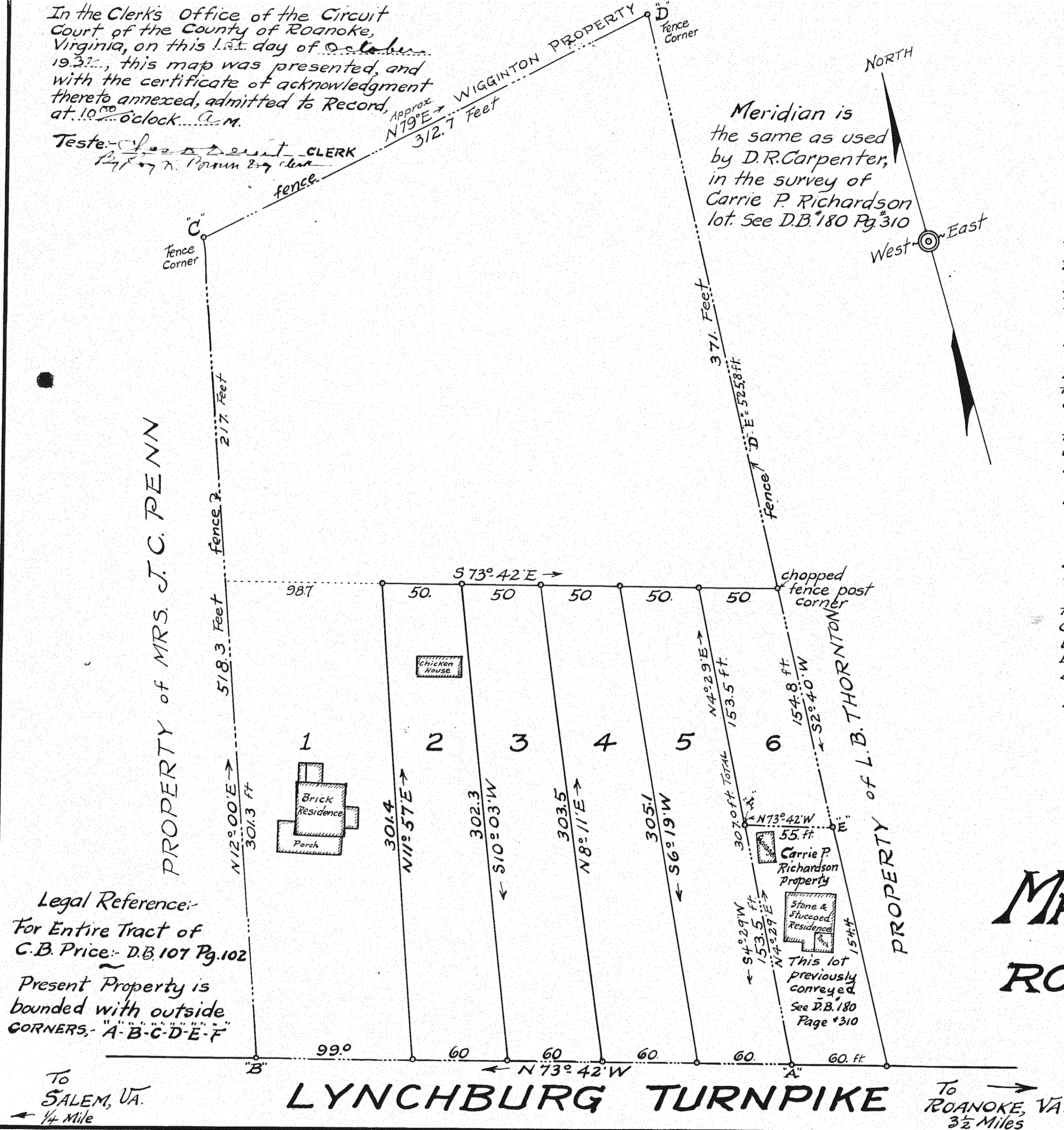

KNOW ALL MEN BY THESE PRESENTS: To Wit

That Cebby B. Price is the owner of the boundary of land, shown hereon, subdivided into lots, the out-side boundary line being described as follows:-

Beginning at a point on the northerly side of the LYNCHBURG TURNPIKE at the south-west corner of the property previously conveyed from Cebby B. Price to Carrie P. Richardson, thence along the north side of the Lynchburg Turnpike, N73°42'W 339 feet to a point, thence leaving the Turnpike, and with the easterly line of the property of Mrs. J.C. PENN, N12°00'E, 518.3 ft. to a point, thence approximately N79°E 312.7 feet to a point, thence with the westerly line of the property of L.B.
