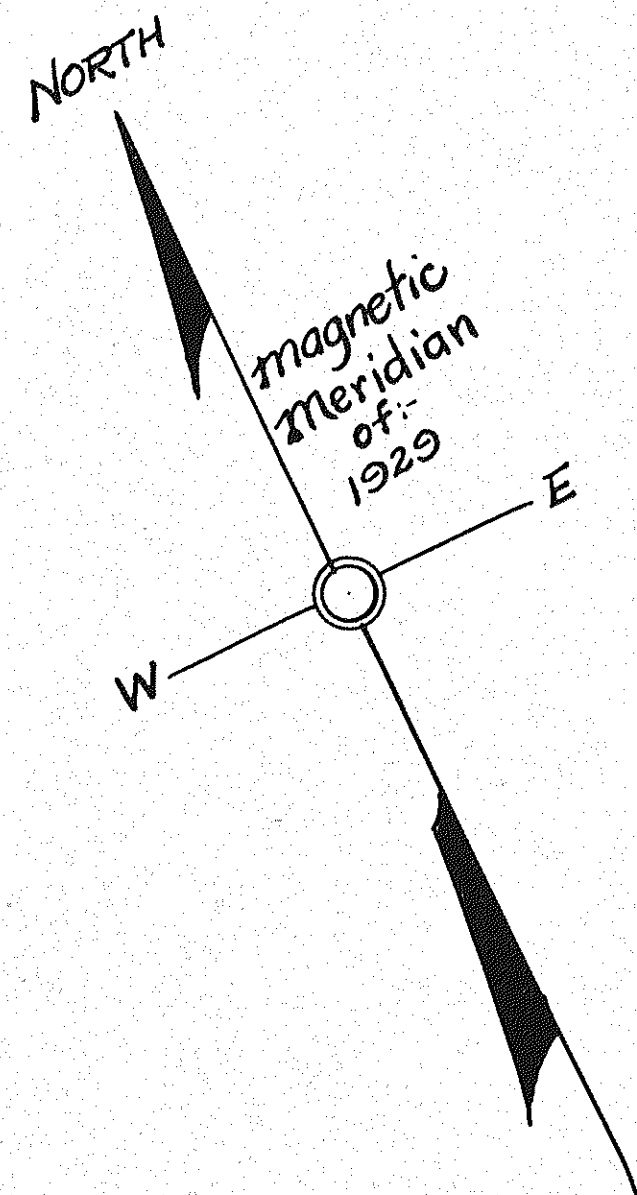




Reservations:-
