

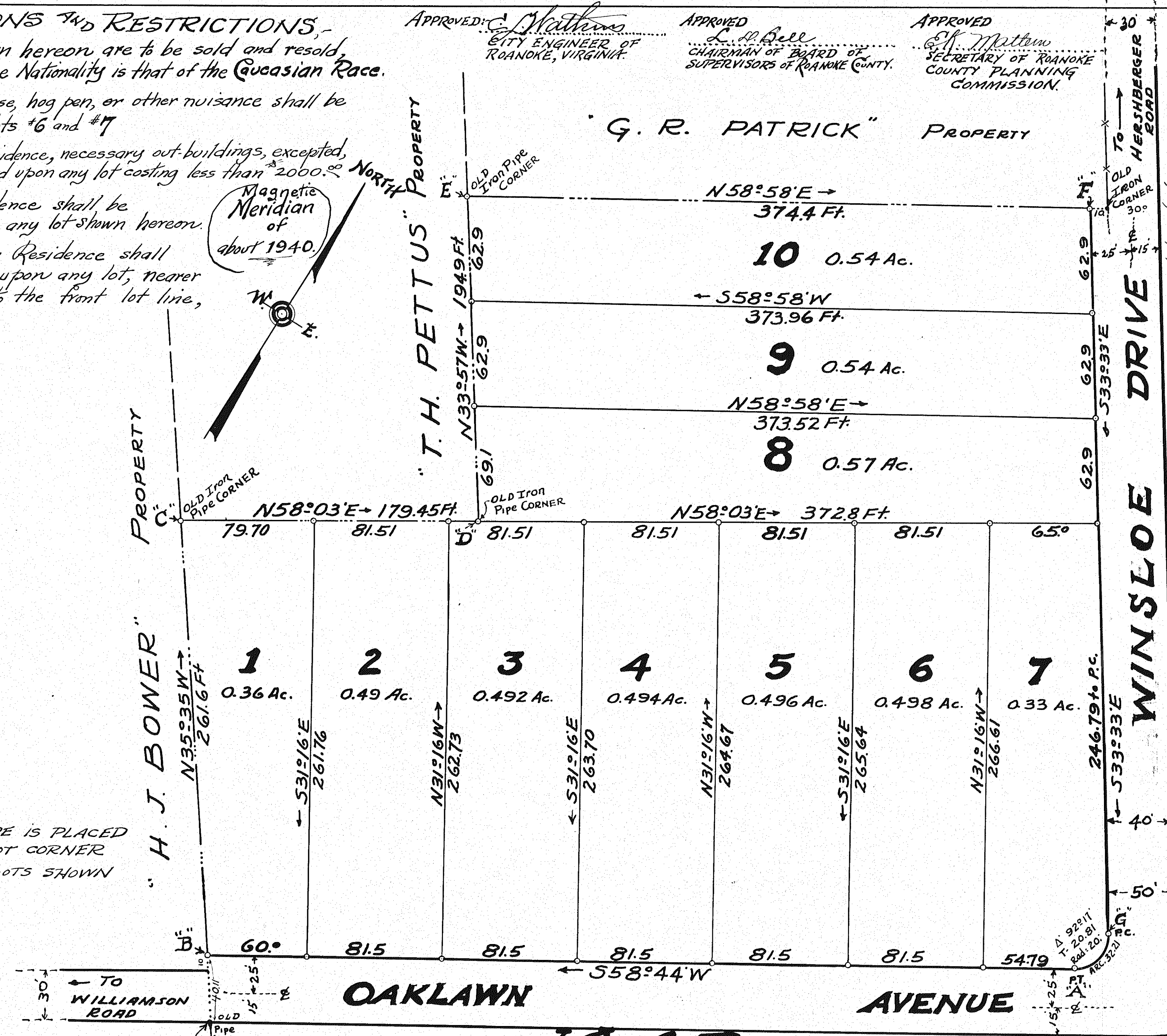
RESERVATIONS AND RESTRICTIONS.
