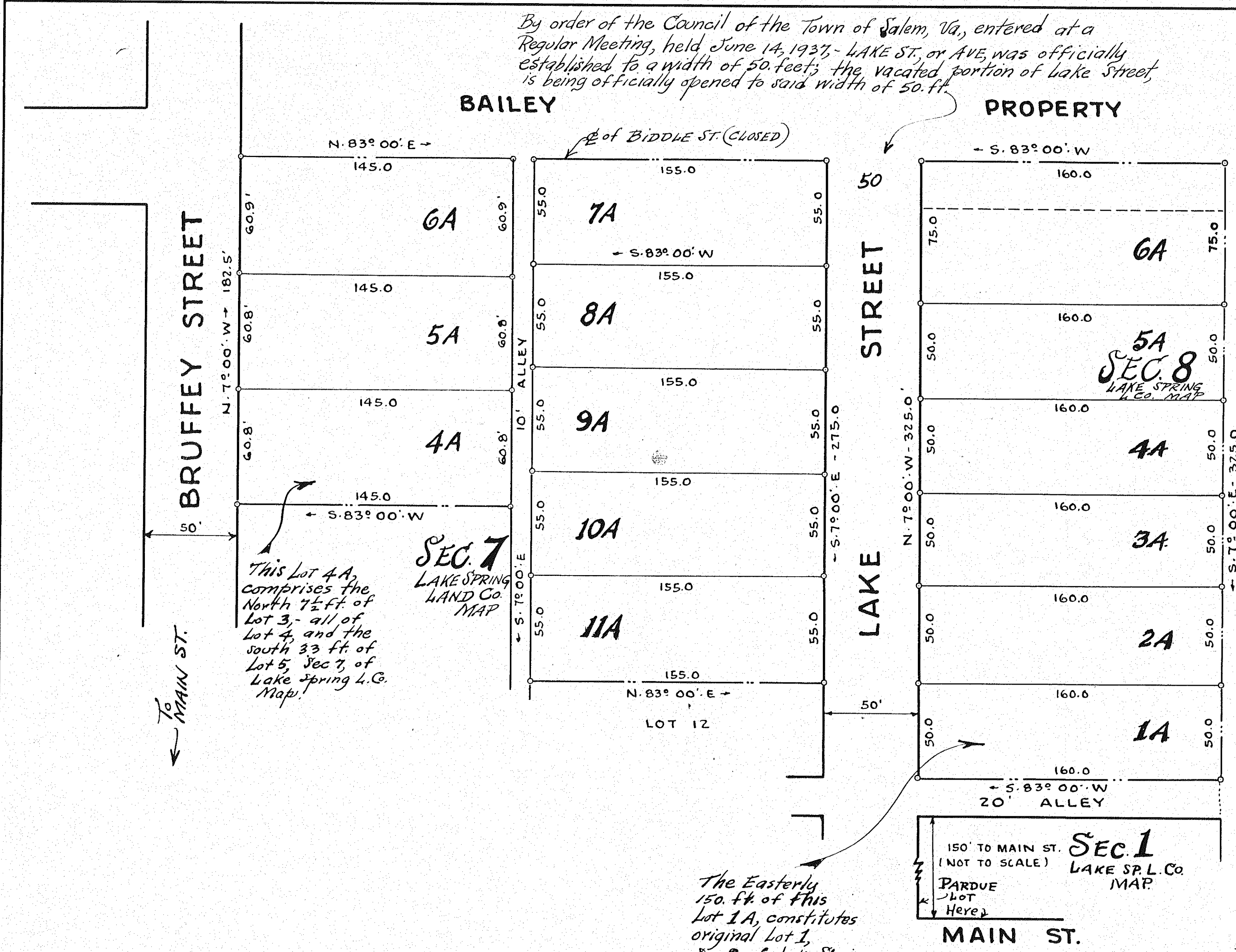


By order of the Council of the Town of Salem, Va., entered at a Regular Meeting, held June 14, 1937, LAKE ST. or AVE. was officially established to a width of 50 feet; the vacated portion of Lake Street is being officially opened to said width of 50 ft.



At a Regular Meeting of the Council of the Town of Salem, Virginia, held May 12, 1941, all members being present, on motion the following ordinance was unanimously adopted: Whereas, on application of L.L. Rush, be it ordained by the Council of the Town of Salem, that the plat and subdivision, known as property of L.L. Rush, which constitutes a replatting of a portion of ground known as "LAKE SPRING LAND COMPANY" as shown on the original Map of "LAKE SPRING LAND COMPANY" (a plat of which is recorded at Page 31 of Plat Record Book No. 1 of the Records of the Clerk's Office of the Circuit Court of Roanoke County, Va.) be, and the same is hereby approved, and the Clerk of the Council is hereby directed to certify a copy of this ORDINANCE, on the original plat of the property of L.L. RUSH, which original is to be recorded in the Clerk's Office of the Circuit Court of Roanoke County, Va. A True Copy Teste: W. J. L. Chapman Clerk of Council of Town of Salem.

The annexed subdivision is in accordance with a Survey, made by C.B. Malcolm, Engr., March 22, 1941, comprising all of the remaining lands of R.S. Kime, in Sections 7 and 8, of said LAKE SPRING LAND Co. Map, as shown hereon by the aforesaid 14 numerated lots.

The said subdivision and annexed plat is with the free will and consent of the undersigned owner, and in accordance with his desire, as required by Sections 5218 and 5710A of the Code of Virginia.
