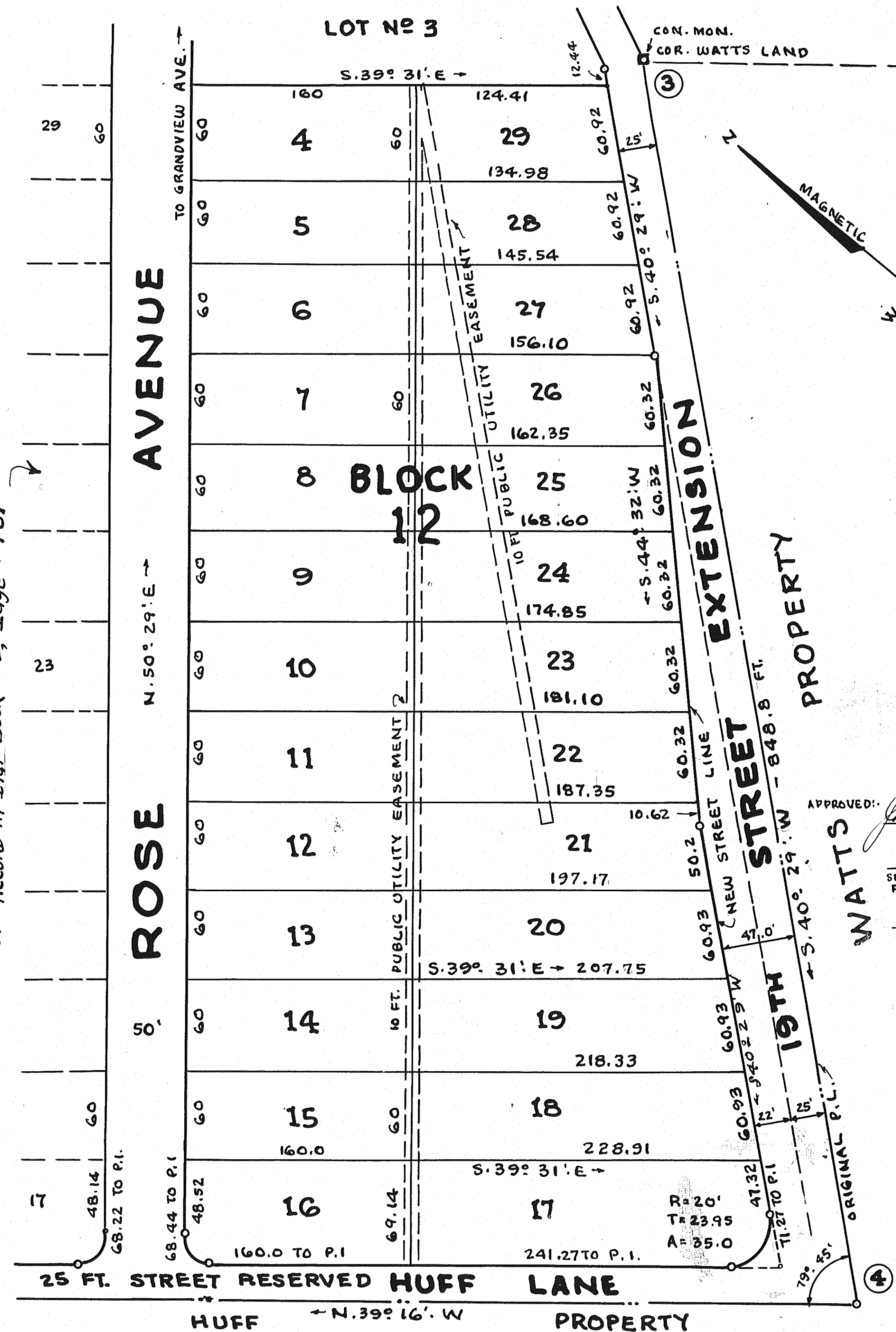


See Map of "DORCHESTER COURT"
