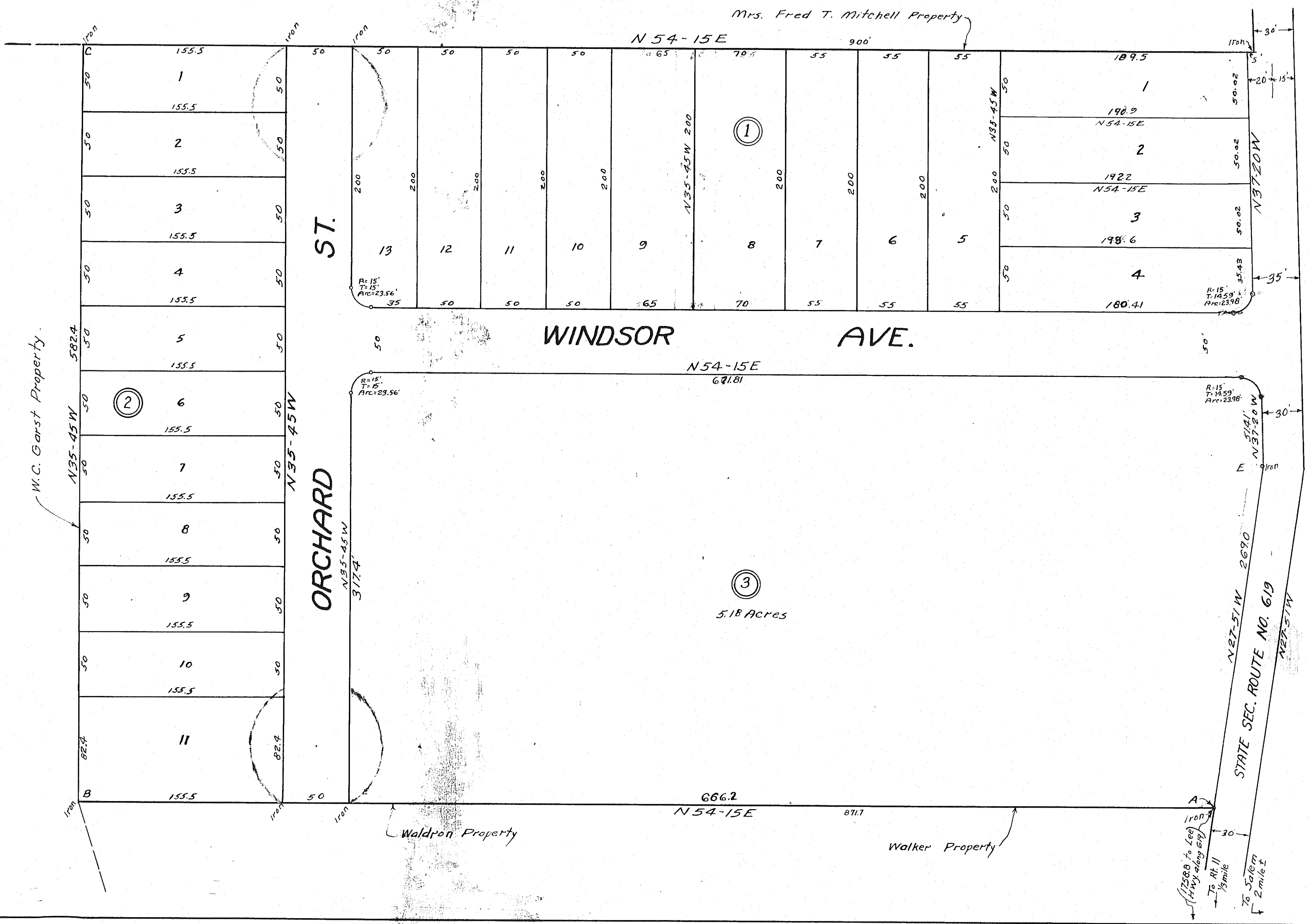
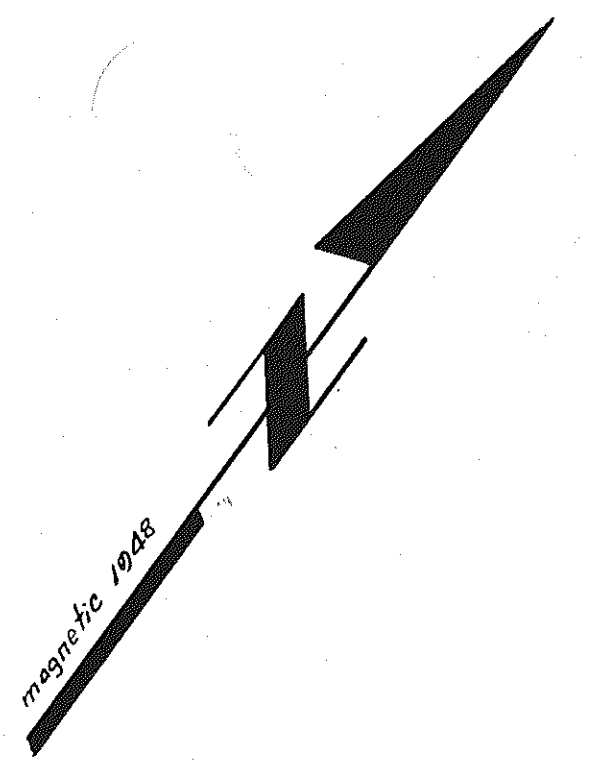


MAP OF
