5. No dwelling shall be erected or placed on any lot or portion of lot or lots having a width of less than 60' at the minimum setback line, or on any lot having an area of less than 7200 square feet.

6. Easements for installation and maintenance of utilities and drainage facilities are reserved as shown on plat over the front 5 feet of each lot.

7. No noxious or offensive activity shall be carried on upon any lot, nor shall anything be done thereon which may become an annoyance or nuisance to the neighborhood.

8. No structure of a temporary character, trailer, basement, tent, shack, garage, barn or other outbuilding shall be used on any lot at any time as a residence either temporarily or permanently.

9. No sign of any kind shall be displayed to the public view on any lot except one professional sign of not more than one square foot, one sign of not more than 5 square feet advertising the property for sale or rent, or signs used by a builder to advertise the property during the construction or sales period.

10. No animals, livestock or poultry of any kind shall be raised, bred or kept on any lot, except that dogs, cats or other household pets may be kept provided that they are not kept, bred, or maintained for any commercial purpose.

11. No lot shall be used or maintained as a dumping ground for rubbish, trash, garbage or other waste shall be kept except in sanitary containers. All incinerators or other equipment for the storage or disposal of such material shall be kept in a clean and sanitary condition.

12. No individual sewage disposal system shall be permitted on any lot unless such system is designed, located or constructed in accordance with the requirements, standards and recommendations of the public health authority controlling same. Approval of such system as installed shall be obtained from the public health authority.

13. A protective screening area 10' in width is established on the lots in Block B along the Norfolk & Western Ry. property line. Planting, fences or walls shall be maintained throughout the entire length of this area by the owner or owners of the lots at their own expense to form an effective screen for the protection of the residential area.

No building or structure except a screen fence or wall or utilities or drainage facilities shall be placed or permitted to remain in this area. Vehicles shall not be driven over the screening area, except for the purpose of installation and maintenance of screening, utilities and drainage facilities.

RESERVATIONS & RESTRICTIONS.

The following reservations and restrictions shall be in force and constitute covenants running with the title to the lots shown hereon for a period of twenty-five years from the date of recordation of Section 2, Park Place, after which time said covenants shall be automatically extended for successive periods of ten years unless an instrument signed by a majority of the then owners of the lots has been recorded agreeing to change said covenants in whole or in part.

1. No lot shall be used except for residential purposes. No building shall be erected, altered, placed or permitted to remain on any lot other than one detached single family dwelling not to exceed two and one-half stories in height and a private garage for not more than two cars.

2. No building shall be erected or moved on to any lot unless it conforms in external design with existing buildings in the subdivisions.

3. No dwelling shall be permitted on any lot costing less than \$10,000.00 or the equivalent value of \$10,000.00 in 1952, exclusive of cost of garage or outbuildings. The ground floor area of the main structure, exclusive of one story open porches and garages shall be not less than 720 square feet for a one story dwelling, nor less than 600 square feet for a dwelling of more than one story.

4. No building shall be located on any lot nearer to the front lot line or nearer to the side street line than the minimum setback lines shown as B.L. on plat, or in any event not nearer than 25 feet from the front lot or side street line. No building shall be located nearer than 10 feet to an interior lot line except that no side yard shall be required for a garage or other permitted accessory building located 75 feet or more from the minimum building setback line. Eaves, steps and open porches shall not be considered as a part of a building, provided however, that this shall not be construed to permit any portion of a building, including eaves, to encroach upon another lot.
