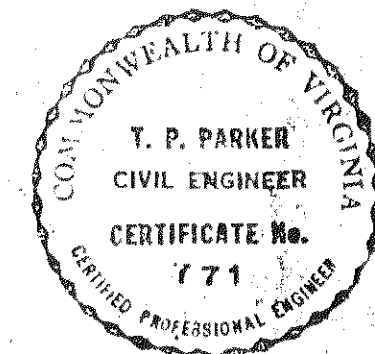


HILLCREST HEIGHTS

said owners hereby certify that they have subdivided
the same into lots as shown hereon entirely with

Code of Virginia. The said owners as a condition
precedent to the approval of this plat and the accept-
ance of the dedication of the streets shown hereon,
by the Council of the Town of Salem, doth specifically
release the Town of Salem from any and all claims or
claims for damages which said owner, its successors
and assigns may or might have against the Town of
Salem by reason of establishing proper grade lines
on and along such streets and alleys as shown
hereon, or by reason of doing necessary grading and
filling for the purpose of placing such streets and
alleys upon the proper grade as may from time to
time be established by said Town, and said Town
shall not be required to construct any retaining wall,
or walls, along the streets and alleys and property lines
thereof.
