SECTION No 2

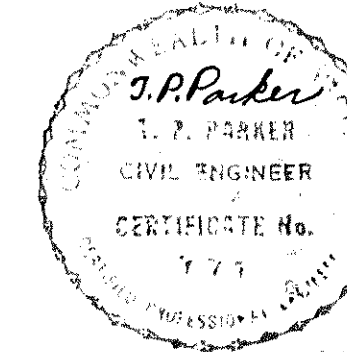
GREEN VALLEYS

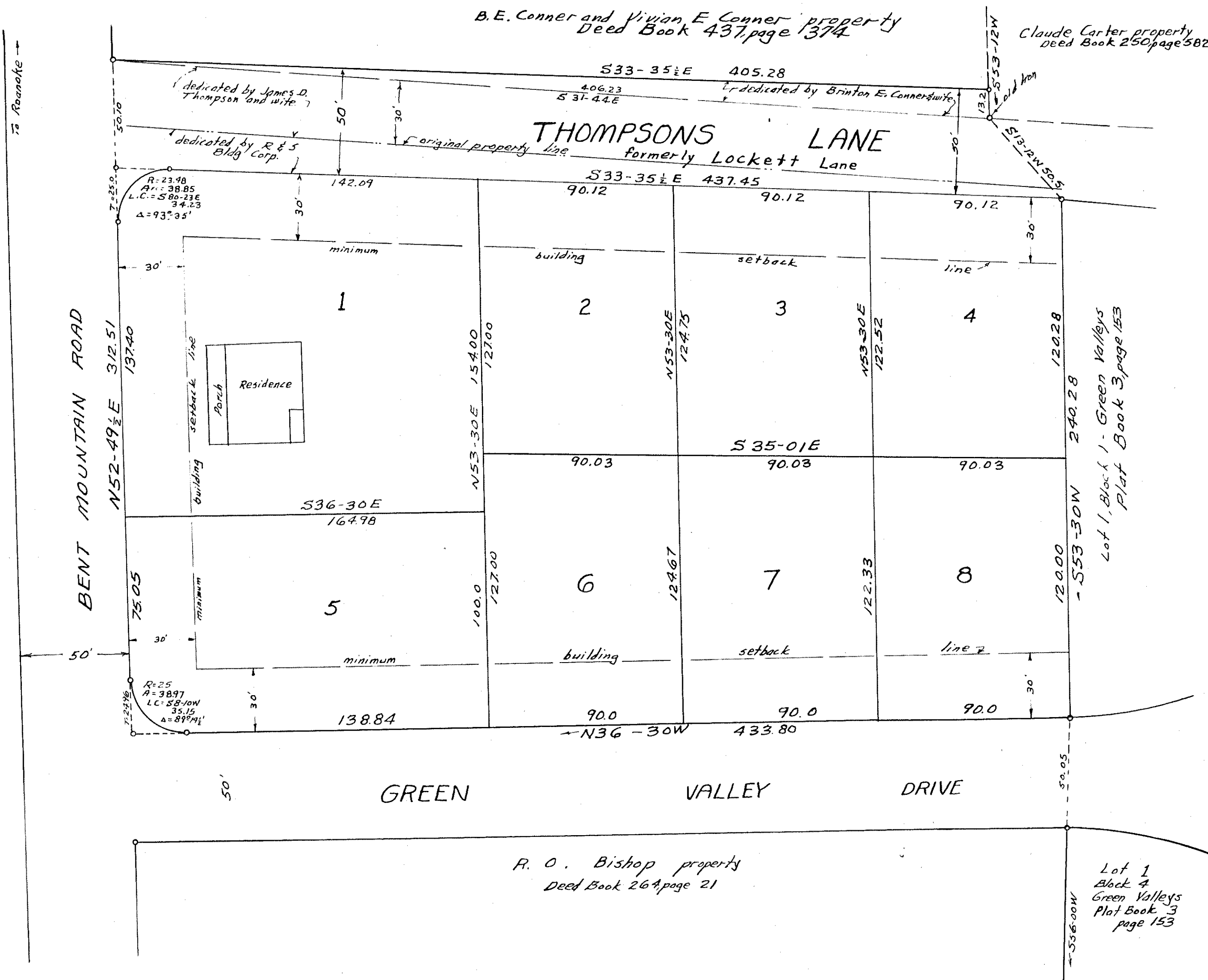
