Know all men by these presents, to wit:
That John A. Slovensky and Ruth S. Slovensky are the owners of the tract of land shown hereon, subdivided into lots as shown hereon and known as Section No. 1, Castle Rock Farms, which said property is a portion of tract of land which was conveyed to John A. Slovensky by Bernice Burns Cook, Widow by deed dated Dec. 29, 1959 and recorded in Deed Book 633, page 132, subject only to a Deed of Trust dated Dec. 29, 1959 from John A. Slovensky to J. D. Copenhaver and R. T. Edwards, Trustees, securing Bernice Burns Cook, Beneficiary, the payment of a certain debt, and recorded in Deed Book 633, page 135. The said owners hereby certify that they have subdivided this land into lots as shown hereon entirely with their own free will and accord as required by Sections 15-779 through 15-794.3 of the 1950 Code of Virginia.
The said owners, with the consent of the undersigned Trustees and Beneficiary, hereby dedicate the streets and easements as shown hereon, to the County of Roanoke in fee simple.
The said owners, with the consent of the undersigned Trustees and Beneficiary, do as a condition precedent to the approval of this plat and subdivision and the acceptance of the dedication of the streets as shown hereon by the Board of Supervisors of Roanoke County, Va., on their own behalf and for and on account of their heirs, successors, devisees and assigns, specifically release the County of Roanoke and Virginia Department of Highways from any and all claim or claims for damages which said owners, their heirs, successors, devisees and assigns, may or might have against the County of Roanoke or Virginia Department of Highways by reason of establishing proper grade lines on and along the streets shown hereon, and by reason of doing the necessary grading, cutting and filling for the purpose of placing such streets upon the proper grade as may from time to time be established by the County of Roanoke or Virginia Department of Highways, and said County and Virginia Department of Highways shall not be required to construct any retaining wall or walls along the streets as shown hereon.
