CRONK, HIS WIFE, ARE THE FEE SIMPLE OWNERS AND PROPRIETORS OF THE LAND SHOWN HEREON TO BE SUBDIVIDED, KNOWN AS NORTH SPRING GARDENS BOUNDED AS SHOWN HEREON IN DETAIL BY OUTSIDE CORNERS 1 TO 4, WHICH IS A PORTION OF THE LAND CONVEYED TO SAID OWNERS BY DEED FROM L.G.
