

KNOW ALL MEN BY THESE PRESENTS. TO WIT:

THAT PARKWAY EAST, INC. IS FEE SIMPLE OWNER AND PROPRIETOR OF THE LAND SHOWN HEREON, SUBDIVIDED AND KNOWN AS SECTION NO. 1 "PARKWAY EAST", BOUNDED AS SHOWN HEREON, IN DETAIL BY OUTSIDE CORNERS I THRU TO TO I, INCLUSIVE WHICH COMPRISES PART OF THE LAND CONVEYED TO SAID OWNER BY DEED DATED MAY 27, 1975 AND RECORDED IN THE CLERK'S OFFICE OF THE CIRCUIT COURT OF ROANOKE COUNTY, VIRGINIA IN DEED BOOK 1019 PAGE 198 AND WHICH LAND IS SUBJECT TO THE LIEN OF A CERTAIN DEED OF TRUST TO JOHN W F. THE SAID OWNER CERTIFIES THAT THE SUBDIVISION OF THE LAND AS SHOWN HEREON INTO LOTS. BLOCKS AND STREETS IS ENTIRELY WITH ITS FREE WILL AND CONSENT AS REQUIRED UNDER SECTION 15.1-465 THRU 15.1-485 OF THE 1950 CODE OF THE COMMONWEALTH OF VIRGINIA. THE SAID OWNER, WITH THE CONSENT OF THE UNDERSIGNED TRUSTEES, DOES BY VIRTUE OF RECORDATION OF THIS PLAT DEDICATE IN FEE SIMPLE TO THE COUNTY OF ROANOKE ALL OF THE LAND EMBRACED WITHIN THE STREETS OF THE SUBDIVISION AND DEDICATES THE EASEMENTS SHOWN HEREON WITHIN THE BOUNDARY TO PUBLIC USE.

THE OWNER DOES AS A CONDITION PRECEDENT TO THE APPROVAL OF THE PLAT AND SUB DIVISION AND ACCEPTANCE OF THE DEDICATION OF THE STREETS SHOWN HEREON BY THE BOARD OF SUPERVISORS OF ROANOKE COUNTY, ON ITS OWN BEHALF AND ON ACCOUNT OF ITS HEIRS, SUCCESSORS, DEVISEES AND ASSIGNS, SPECIFICALLY RELEASES THE COUNTY OF ROANOKE AND THE VIRGINIA DEPARTMENT OF HIGHWAYS FROM ANY AND ALL CLAIM OR CLAIMS FOR DAMAGES WHICH SUCH OWNER. ITS HEIRS, SUCCESSORS, DEVISEES AND ASSIGNS MAY OR MIGHT HAVE AGAINST THE COUNTY OR VIRGINIA DEPARTMENT OF HIGHWAYS BY REASON OF ESTABLISHING PROPER GRADI LINES ON AND ALONG SUCH STREETS AS SHOWN ON THE PLAT OF THE LAND SUBDIVIDED (OR SUCH GRADING. CUTTING OR FILLING FOR THE PURPOSE OF PLACING SUCH STREETS UPON THE PROPER GRADE AS MAY, FROM TIME TO TIME, BE ESTABLISHED BY SAID COUNTY OR VIRGINIA DEPARTMENT OF HIGHWAYS, AND SAID COUNTY OR VIRGINIA DEPARTMENT OF HIGHWAYS, SHALL NOT BE REQUIRED TO CONSTRUCT ANY RETAINING WALL OR WALLS ALONG THE STREETS AND PROPERTY LINES THEREOF.



- I. THESE COVENANTS AND RESTRICTIONS AFE MADE COVENANTS RUNNING WITH THE LAND AND SHALL BE BINDING ON ALL LOT OWNERS. THEIR HEIRS, DEVISEES OR ASSIGNS FOR A PERIOD OF THIRTY (30) YEARS FROM THE DATE HEREOF.
- 2. LOTS SHOWN HEREON ARE FOR RESIDENTIAL PURPOSES ONLY.
- 3. MINIMUM LIVING SPACE SHALL BE AS FOLLOWS:
 - (A) SINGLE STORY DWELLINGS SHALL HAVE A MINIMUM FLOOR SPACE OF 1,000 SQ. FEET.
- (B) TWO STORY HOUSES MUST HAVE A MINIMUM OF 750 SQ. FEET ON THE FIRST FLOOR.
- DONE THEREON WHICH MAY BE OR MAY BECOME OBNOXIOUS OR A NUISANCE TO THE NEIGHBORHOOD
- OR OTHER OUTBUILDING SHALL BE USED ON ANY LOT AT ANY TIME AS A RESIDENCE, EITHER TEM PORARILY OR PERMANENTLY.
- PROFESSIONAL SIGN OF NOT MORE THAN FIVE SQUARE FEET OR TWO SIGNS OF NOT MORE THAN TEN SQUARE FEET ADVERTISING THE PROPERTY FOR SALE, OR RENT.
- ARE NOT KEPT, BRED OR MAINTAINED FOR ANY COMMERCIAL PURPOSE.
- INCINERATORS OR OTHER EQUIPMENT FOR THE STORAGE OR DISPOSAL OF SUCH MATERIAL SHALL BE PUBLIC VIEW UNLESS THE SAME CARRIES A CURRENT VALID STATE INSPECTION CERTIFICATE.
- THE FOREGOING COVENANTS AND RESTRICTIONS BE DECLARED INVALID, THE SAME WILL NOT INVALIDATE

- 4. NO NOXIOUS OR OFFENSIVE ACTIVITY SHALL BE CARRIED ON UPON ANY LOT NOR SHALL ANYTHING BE
- 5. NO STRUCTURE OF A TEMPORARY CHARACTER, TRAILER, BASEMENT, TENT, SHACK, GARAGE, BARN,
- 6. NO SIGN OF ANY KIND SHALL BE DISPLAYED TO THE PUBLIC VIEW ON ANY LOT EXCEPT ONE
- 7. NO ANIMALS, LIVESTOCK, OR POULTRY OF ANY KIND SHALL BE RAISED, BRED OR KEPT ON ANY LOT, EXCEPT THAT DOGS, CATS OR OTHER HOUSEHOLD PETS MAY BE KEPT, PROVIDED THAT THEY
- 8. TRASH, GARBAGE OR OTHER WASTE SHALL NOT BE KEPT EXCEPT IN SANITARY CONTAINERS. ALL KEPT IN A CLEAN AND SANITARY CONDITION. NO AUTOMOBILE SHALL BE KEPT ON THE PREMISES IN
- 9. SHOULD ANY PROCEEDINGS AT LAW OR IN EQUITY DECREE THAT ANY ONE OR PART OF ANY ONE OF ALL OR ANY PART OF THE REMAINING COVENANTS AND RESTRICTIONS.

- 10. THE ENFORCEMENT OF ANY OF THE COVENANTS AND RESTRICTIONS HEREIN CONTAINED MAY BE BY PROCEEDINGS AT LAW, OR IN EQUITY AGAINST ANY PERSON OR PERSONS VIOLATING OR ATTEMPTING TO VIOLATE ANY OF THE AFORESAID COVENANTS AND RESTRICTIONS EITHER BY INJUNCTION OR TO RECOVER DAMAGES FOR VIOLATION THEREOF.
- UPON THE EXPIRATION OF THE FOREGOING COVENANTS, AS PRESCRIBED IN PARAGRAPH NUMBERED (10) ABOVE, THEY SHALL BE RENEWED AUTOMATICALLY FOR THREE (3) SUCCESSIVE PERIODS OF TEN (10) YEARS EACH UNLESS THERE IS RECORDED AN INSTRUMENT EXECUTED BY A MAJORITY OF THE OWNERS OF THE LOTS AFFECTED BY THE COVENANTS HEREIN CONTAINED WHICH SETS FORTH AN AGREEMENT TO TERMINATE OR MODIFY SAID COVENANTS.
