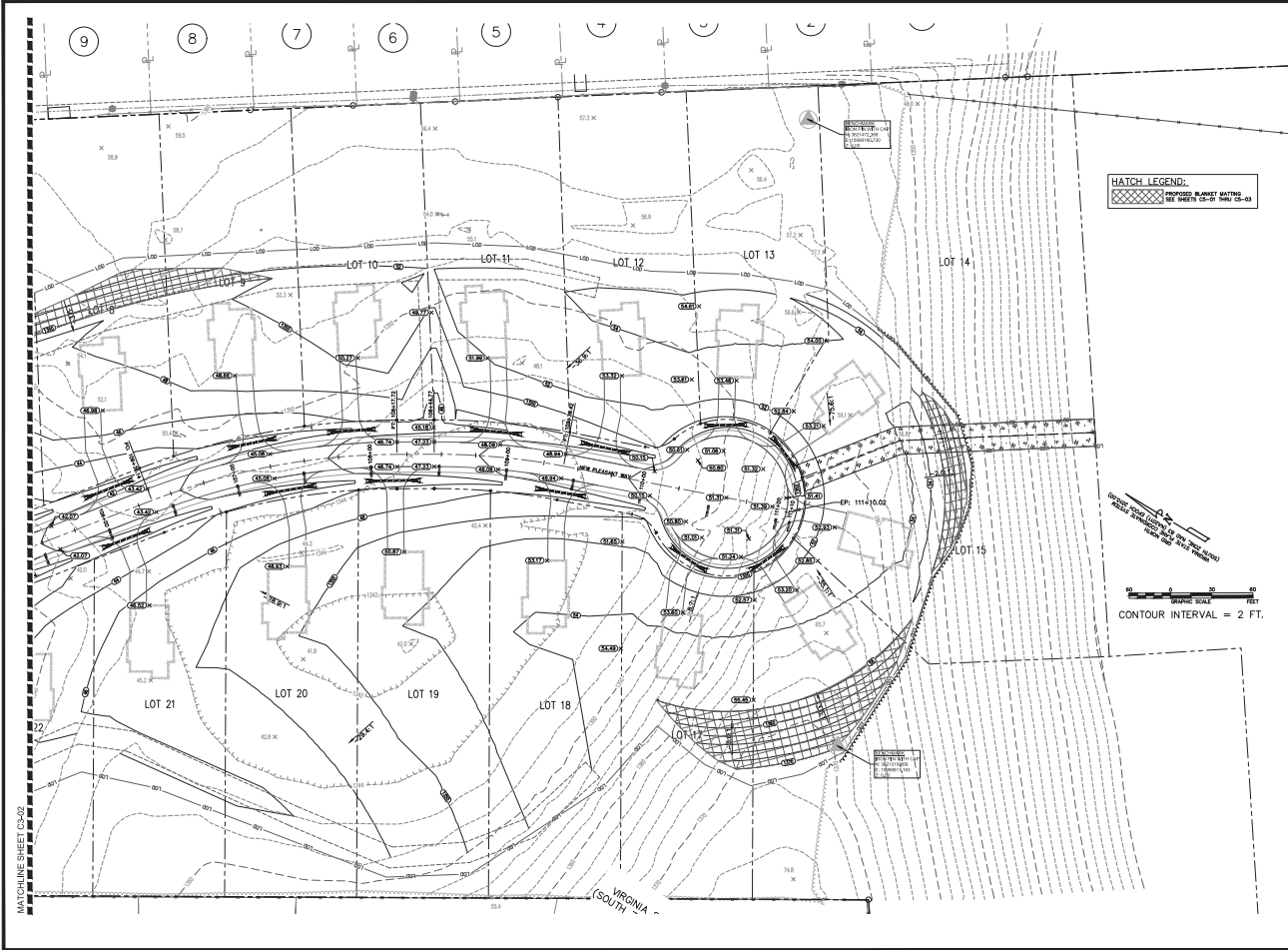
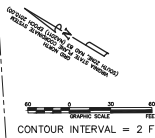




HATCH LEGEND:
