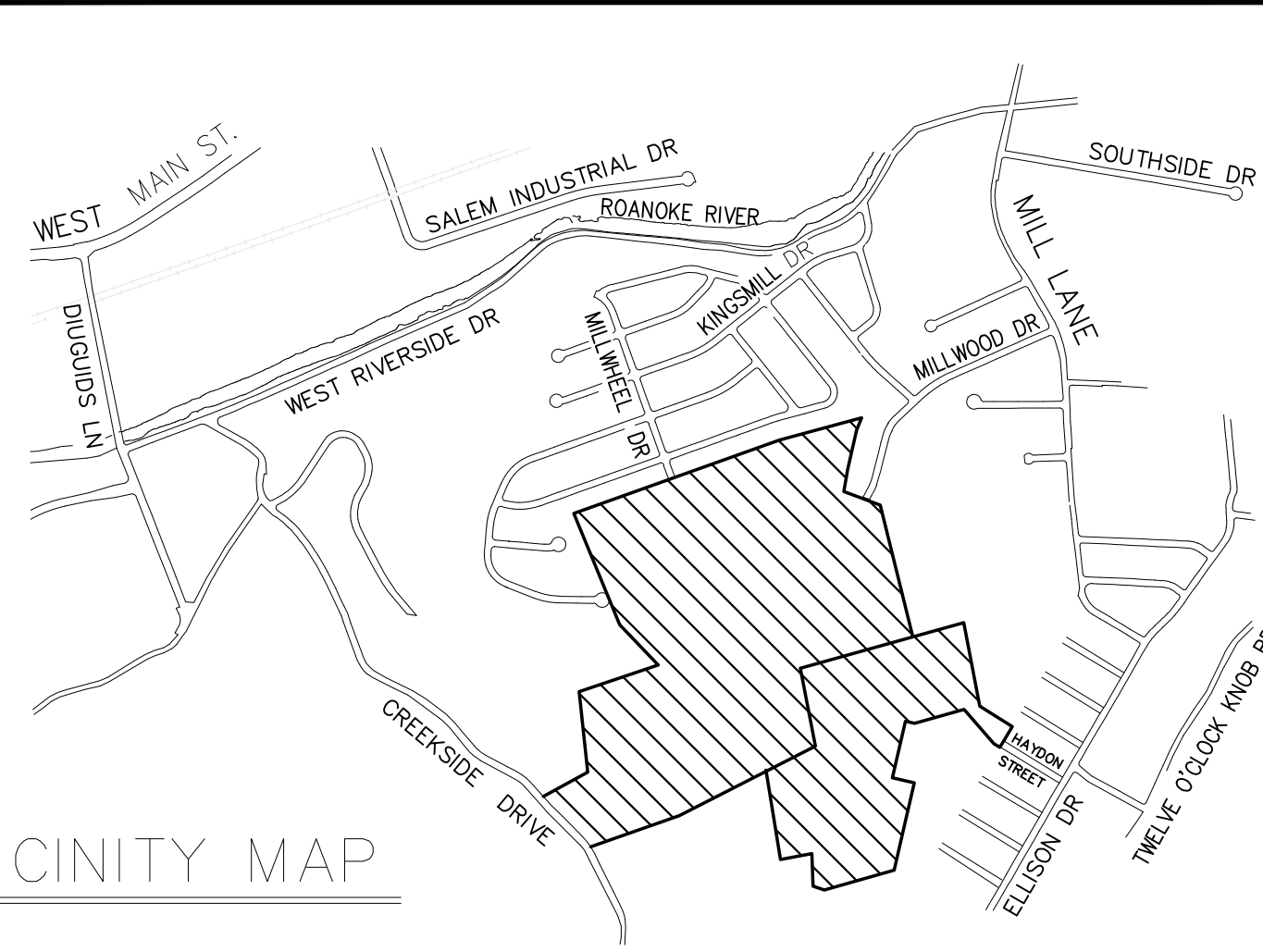


VICINITY MAP

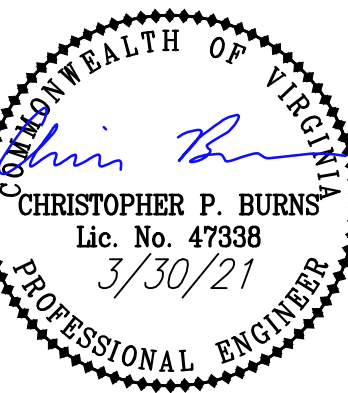
