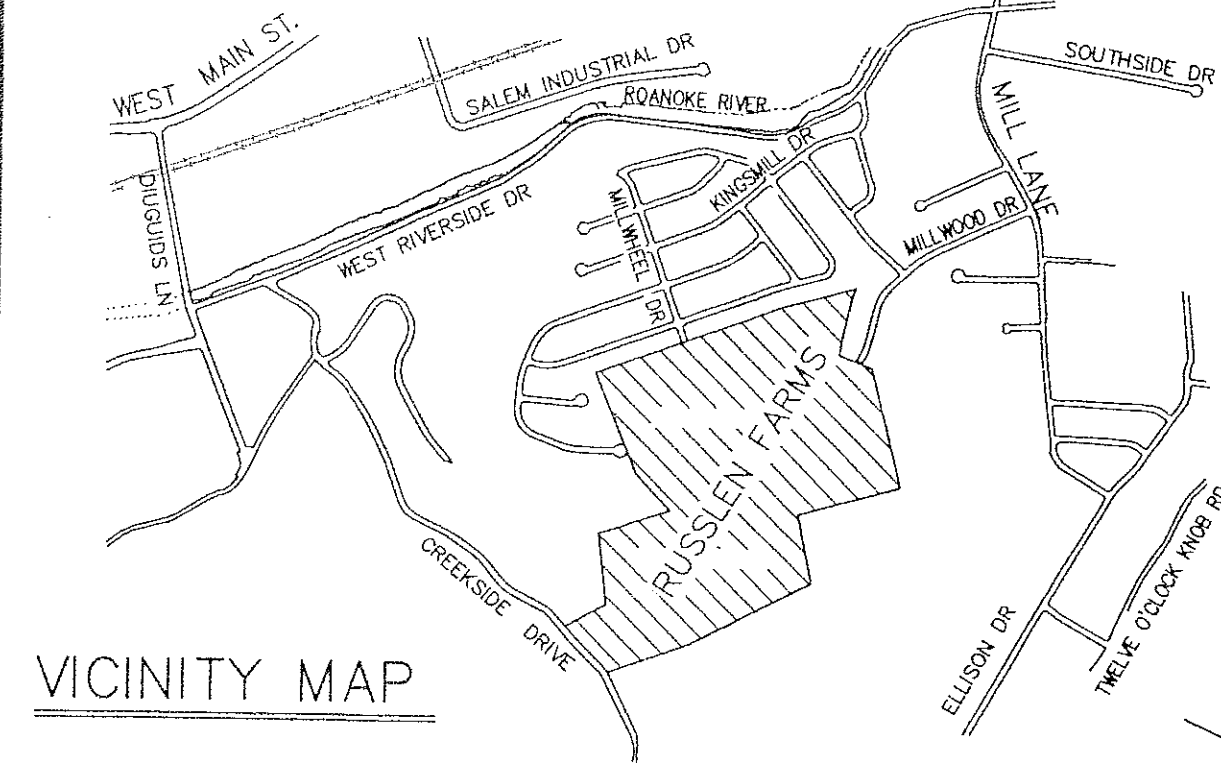


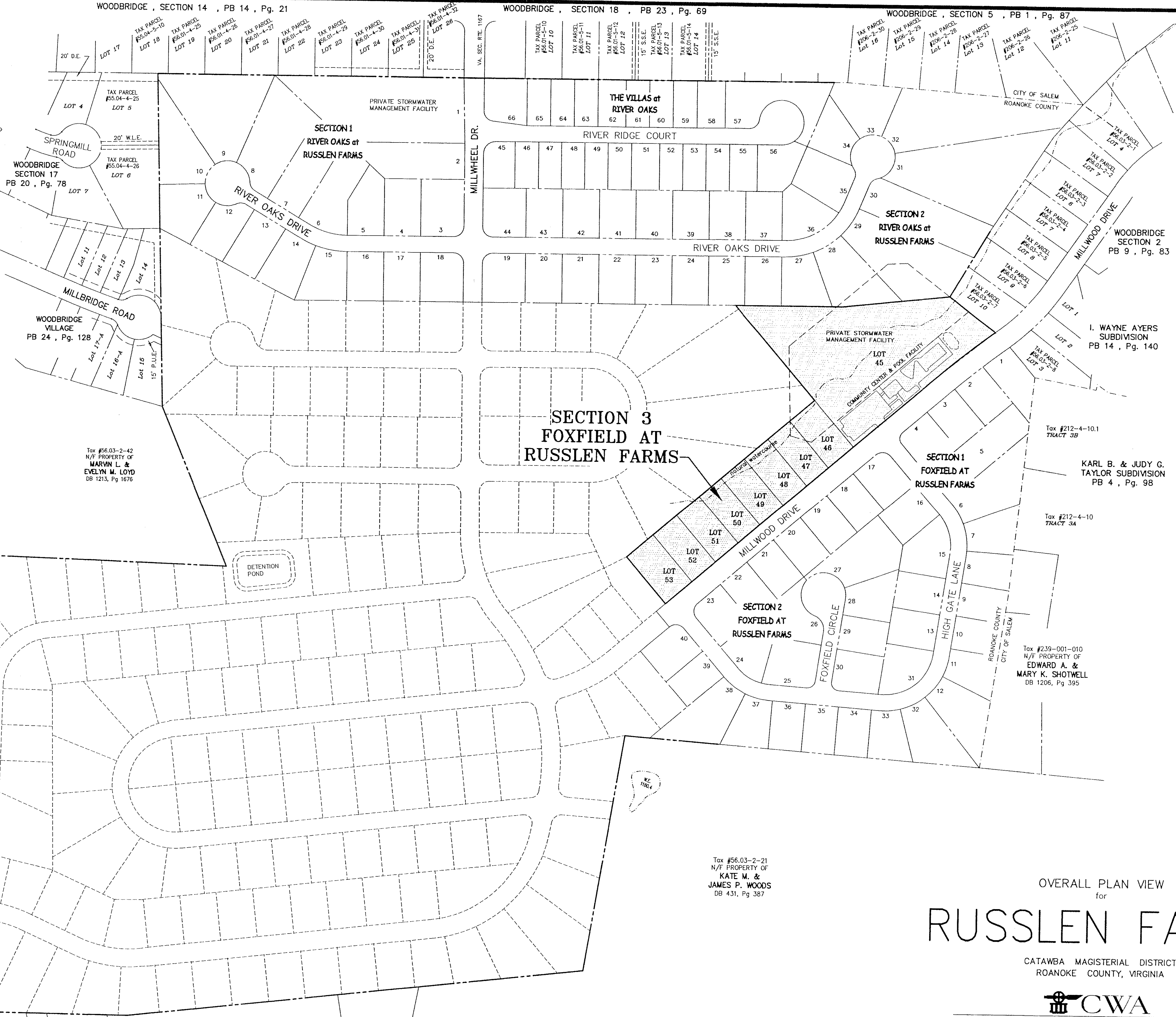


VICINITY MAP

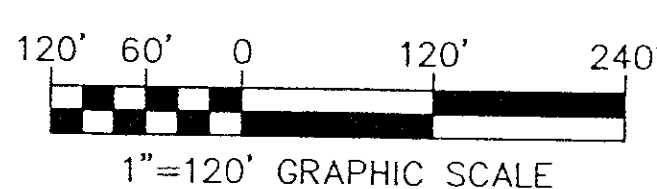


OVERALL PLAN VIEW
