Hydrologic soil groups are based on estimates of runoff potential. Soils are assigned to one of four groups according to the rate of water infiltration when the soils are not protected by vegetation, are thoroughly wet, and receive precipitation from long-duration storms.

The soils in the United States are assigned to four groups (A, B, C, and D) and three dual classes (A/D, B/D, and C/D). The groups are defined as follows: Group A. Soils having a high infiltration rate (low runoff potential) when

thoroughly wet. These consist mainly of deep, well drained to excessively drained sands or gravelly sands. These soils have a high rate of water

Group B. Soils having a moderate infiltration rate when thoroughly wet. These consist chiefly of moderately deep or deep, moderately well drained or well drained soils that have moderately fine texture to moderately coarse texture. These soils have a moderate rate of water transmission.

Group C. Soils having a slow infiltration rate when thoroughly wet. These consist chiefly of soils having a layer that impedes the downward movement of water or soils of moderately fine texture or fine texture. These soils have a slow rate of water transmission.

Group D. Soils having a very slow infiltration rate (high runoff potential) when thoroughly wet. These consist chiefly of clays that have a high shrink-swell potential, soils that have a high water table, soils that have a claypan or clay layer at or near the surface, and soils that are shallow over nearly impervious material. These soils have a very slow rate of water transmission.

If a soil is assigned to a dual hydrologic group (A/D, B/D, or C/D), the first letter is for drained areas and the second is for undrained areas. Only the soils that in their natural condition are in group D are assigned to dual classes.

# EROSION AND SEDIMENT CONTROL NARRATIVE

PROJECT DESCRIPTION: THIS PROJECT CONSISTS OF THE CONSTRUCTION OF TWO GENERAL OFFICE BUILDINGS WITH ASSOCIATED PARKING AND UTILITY IMPROVEMENTS. THE SITE IS LOCATED ON WENDOVER ROAD IN BOTETOURT COUNTY. THE SITE GENERALLY SLOPES FROM EAST TO WEST. THE TOTAL DISTURBED AREA IS APPROXIMATELY 1.7 ACRES.

EXISTING SITE CONDITIONS: THE PROPOSED SITE IS CURRENTLY COMPRISED OF ONE LOT THAT CONTAINS A COMMERCIAL BUILDING AND GRAVEL PARKING AREA AND THREE VACANT LOTS COMPRISED MAINLY OF MANAGED TURF AND EXISTING

ADJACENT AREAS: THE SITE IS BORDERED ON THE NORTH BY PROPERTIES ZONED B2 AND R1, ON THE EAST BY THE PUBLIC RIGHT OF WAY OF ORCHARD DRIVE (ROUTE 795), ON THE SOUTH BY THE PUBLIC RIGHT OF WAY OF WENDOVER ROAD (ROUTE 794), AND ON THE WEST BY THE PUBLIC RIGHT OF WAY OF ROANOKE ROAD (ROUTE 220).

OFF-SITE AREAS: AT THIS TIME, THERE ARE NO FILL OR BORROW AREAS PLANNED WITH THIS PROJECT, THE CONTRACTOR SHALL NOTIFY BOTETOURT COUNTY OF ANY FILL OR BORROW AREAS PRIOR TO TRANSPORTING ANY MATERIAL ON OR OFF-SITE. EROSION CONTROL MEASURES MAY BE REQUIRED FOR OFF-SITE AREAS ASSOCIATED WITH

SOILS: THE FOLLOWING SOILS INFORMATION IS REFERENCED FROM THE UNITED STATES DEPARTMENT OF AGRICULTURE'S WEB SOIL SURVEY. ACCORDING TO THIS SOIL SURVEY, THE SOILS PRESENT ON-SITE ARE 25D - FREDERICK-URBAN LAND COMPLEX, 15 TO 30 PERCENT SLOPES (HSG-B), 53B - TIMBERVILLE SILT LOAM, 0 TO 7 PERCENT SLOPES, OCCASIONALLY FLOODED (HSG-B), AND 61 - UDORTHENTS-URBAN LAND COMPLEX.

<u>CRITICAL AREAS NARRATIVE:</u> THE CRITICAL AREAS ON—SITE INCLUDE ALL AREAS NEAR EXISTING PROPERTY LINES AND AREAS ADJACENT TO THE CREEK. THE G.C. SHALL PAY SPECIAL ATTENTION TO THESE AREAS AND ENSURE THAT SEDIMENT IS NOT TRANSPORTED OFF-SITE.

EROSION AND SEDIMENT CONTROL MEASURE NARRATIVE: UNLESS OTHERWISE INDICATED, ALL VEGETATIVE AND STRUCTURAL EROSION AND SEDIMENT CONTROL PRACTICES SHALL BE CONSTRUCTED AND MAINTAINED ACCORDING TO MINIMUM STANDARDS AND SPECIFICATIONS OF THE "VIRGINIA EROSION AND SEDIMENT CONTROL HANDBOOK, THIRD EDITION" (VESCH). THE MINIMUM STANDARDS OF THE VESCH SHALL BE

CONSTRUCTION ENTRANCE-STD. 3.02.....A STONE PAD, LOCATED AT POINTS OF VEHICULAR INGRESS AND EGRESS TO THE CONSTRUCTION SITE. TO REDUCE THE SOIL TRANSPORTED ONTO PUBLIC ROADS AND OTHER PAVED AREAS.

ADHERED TO UNLESS OTHERWISE DIRECTED BY THE LOCAL PROGRAM ADMINISTRATOR.

SILT FENCE-STD. 3.05.....A TEMPORARY BARRIER CONSTRUCTED ALONG THE PERIMETER OF THE DISTURBED AREA AS REQUIRED TO INTERCEPT AND DETAIN SEDIMENT.

TEMPORARY DIVERSION DIKE-STD. 3.09.....A TEMPORARY RIDGE OF COMPACTED SOIL CONSTRUCTED AT THE TOP OR BASE OF A SLOPING DISTURBED AREA TO DIVERT SEDIMENT-LADEN RUNOFF TO A SEDIMENT-TRAPPING FACILITY.

TEMPORARY SEDIMENT TRAP-STD. 3.13.....A TEMPORARY PONDING AREA FORMED BY CONSTRUCTING AN EARTHEN EMBANKMENT WITH A STONE OUTLET TO DETAIN SEDIMENT-LADEN RUNOFF FROM SMALL DISTURBED AREAS LONG ENOUGH TO ALLOW THE MAJORITY OF THE SEDIMENT TO SETTLE OUT.

ROCK CHECK DAMS-STD. 3.20....SMALL, TEMPORARY STONE DAMS CONSTRUCTED ACROSS A DRAINAGE DITCH TO REDUCE THE VELOCITY OF CONCENTRATED FLOWS, REDUCING EROSION OF THE DITCH.

### <u>VEGETATIVE</u> -

TEMPORARY SEEDING-STD. 3.31....ESTABLISHMENT OF A TEMPORARY VEGETATIVE COVER ON DISTURBED AREAS THAT WILL NOT BE BROUGHT TO FINAL GRADE FOR PERIODS OF 14 DAYS TO 1-YEAR BY SEEDING WITH AN APPROPRIATE RAPIDLY GROWING SEED MIXTURE.

PERMANENT SEEDING-STD. 3.32....ESTABLISHMENT OF PERENNIAL VEGETATIVE COVER ON DISTURBED AREAS BY PLANTING SEED TO REDUCE EROSION AND DECREASE SEDIMENT YIELD FROM DISTURBED AREAS.

MULCHING-STD. 3.35....MULCH SHALL BE APPLIED TO ALL TEMPORARY AND PERMANENT SEEDING OPERATIONS TO PROMOTE THE GROWTH OF VEGETATION AND TO PROTECT THE SOIL SURFACE FROM RAINDROP IMPACTS.

## MANAGEMENT STRATEGIES:

A) CONSTRUCTION WILL BE SEQUENCED SO THAT GRADING OPERATIONS CAN BEGIN AND END AS QUICKLY AS POSSIBLE. SEDIMENT TRAPPING MEASURES WILL BE INSTALLED AS A FIRST STEP IN GRADING.

C) THE LOCAL PROGRAM ADMINISTRATOR RESERVES THE RIGHT TO ADD TO, DELETE OR OTHERWISE CHANGE THE EROSION CONTROL MEASURES AS DEEMED NECESSARY DUE TO ACTUAL FIELD CONDITIONS BY WRITTEN NOTIFICATION TO

D) ALL FILL AND CUT SLOPES SHALL BE SEEDED WITHIN SEVEN (7) DAYS OF ACHIEVING FINAL GRADE. E) ONLY AFTER INSPECTION AND APPROVAL FROM THE LOCAL PROGRAM ADMINISTRATOR MAY ITEMS BE REMOVED FOLLOWING THE STABILIZATION OF THE CONTRIBUTING AREAS.

SITE STABILIZATION NARRATIVE: ALL AREAS DISTURBED BY CONSTRUCTION THAT DO NOT RECEIVE PAVEMENT, CONCRETE, OR OTHER HARDSCAPE MATERIAL, SHALL BE PERMANENTLY STABILIZED IMMEDIATELY FOLLOWING FINISHED GRADING. PERMANENT STABILIZATION SHALL BE PER THE DETAILS ON SHEET C8 WITHIN THIS PLAN SET.

# STORMWATER RUNOFF AND ADEQUATE CHANNEL NARRATIVE:

STORMWATER CALCULATIONS SHOW THAT THE ON-SITE RUNOFF REACHES THE 1% POINT AT THE ON-SITE CREEK. PLEASE REFER TO THE DESIGN CALCULATIONS FOR THE PROPOSED STORMWATER MANAGEMENT IMPROVEMENTS FOR COMPLIANCE WITH CHANNEL AND FLOOD PROTECTION REQUIREMENTS UP TO THIS POINT. NUTRIENT CREDITS WILL BE PURCHASED TO MEET STORMWATER QUALITY REQUIREMENTS.

MAINTENANCE/INSPECTIONS:
THE GENERAL CONTRACTOR SHALL INSPECT DISTURBED AREAS OF THE SITE THAT HAVE NOT BEEN FINALLY STABILIZED, AND AREAS USED FOR STORAGE OF MATERIALS THAT ARE EXPOSED TO PRECIPITATION, STRUCTURAL CONTROL MEASURES, AND THE AREA OF CONSTRUCTION VEHICLE ACCESS AT LEAST EVERY FOURTEEN (14) CALENDAR DAYS, AND WITHIN 48 HOURS OF THE END OF A STORM EVENT PRODUCING 1/2" OR GREATER OF PRECIPITATION. WHERE AREAS HAVE BEEN FINALLY OR TEMPORARILY STABILIZED OR RUNOFF IS UNLIKELY DUE TO WINTER CONDITIONS (SITE IS COVERED WITH SNOW, ICE, OR FROZEN GROUND EXISTS) SUCH INSPECTIONS SHALL BE CONDUCTED AT LEAST ONCE

A) INSPECT DISTURBED AREAS AND AREAS OF MATERIALS STORAGE THAT ARE EXPOSED TO PRECIPITATION FOR EVIDENCE OF, OR THE POTENTIAL FOR SEDIMENT ENTERING THE STORM DRAIN SYSTEM. INSPECT E&S CONTROLS IN ACCORDANCE WITH REQUIREMENTS STATED HEREIN, AND INSPECT POINTS OF STORM DRAIN DISCHARGE FOR EXCESSIVE SEDIMENTATION. CORRECT SITE CONTROLS AS REQUIRED TO REDUCE SEDIMENTATION OF STORM DRAINS, CULVERTS, AND

RECEIVING CHANNELS. B) IF CONTROLS OR SEDIMENT PREVENTION AREAS ARE FOUND TO BE IN NEED OF REPAIR OR MODIFICATION, THE GÉNERAL CONTRACTOR SHALL PROVIDE ADDITIONAL MEASURES OR MODIFICATIONS TO EXISTING MEASURES AS REQUIRED. ANY ADDITIONAL MEASURES OR MODIFICATIONS TO EXISTING MEASURES SHALL BE RECORDED AS FIELD REVISIONS TO THESE PLANS, IN THE EVENT THAT ADDITIONAL CONTROLS ARE FOUND TO BE REQUIRED, THE GENERAL CONTRACTOR SHALL BE RESPONSIBLE FOR IMPLEMENTING THESE CONTROLS BEFORE THE NEXT ANTICIPATED STORM EVENT. IF IMPLEMENTATION BEFORE THE NEXT STORM EVENT IS IMPRACTICAL, THEY SHALL BE IMPLEMENTED AS SOON AS

PRACTICAL. C) A REPORT SUMMARIZING THE SCOPE OF INSPECTIONS, NAME OF INSPECTOR, INSPECTOR'S QUALIFICATIONS, DATES OF INSPECTIONS. MAJOR OBSERVATIONS PERTAINING TO THE IMPLEMENTATION OF THESE EROSION CONTROL PLANS, AND ACTIONS TAKEN SHALL BE MADE AND RETAINED AS A PART OF THESE PLANS. MAJOR OBSERVATIONS OF THESE REPORTS SHALL INCLUDE: THE LOCATIONS OF EXCESSIVE SEDIMENTATION FROM THE SITE; LOCATIONS OF CONTROLS IN NEED OF REPAIR; LOCATIONS OF FAILED OR INADEQUATE CONTROLS; AND LOCATIONS WHERE ADDITIONAL CONTROLS ARE NEEDED.
