- 4. COORDINATE ELECTRICAL SHUT-DOWN AND CUT-OVER WITH APPALACHIAN POWER COMPANY AND FACILITY OPERATIONS.
- 5. COORDINATE DEMOLITION WORK WITH OTHER TRADES AND UTILITIES IN THE BUILDING.
- 6. DEMOLISH ALL EQUIPMENT AND DEVICES INDICATED WITH DASHED LINES, UON. ALL DISCONNECTED CIRCUITS SHALL BE DEMOLISHED BACK TO THEIR SOURCE INCLUDING ALL ASSOCIATED WIRING AND BOXES, UON.
- 7. ELECTRICAL EQUIPMENT LABELED WITH "ETR" ARE EXISTING TO REMAIN. ALL EQUIPMENT SHOWN SHALL BE CONSIDERED EXISTING TO REMAIN.
- 8. ALL DISCONNECTED CIRCUITS SHALL BE REMOVED BACK TO THEIR SOURCE INCLUDING ALL ASSOCIATED WIRING AND BOXES, UON.
- 9. ALL EQUIPMENT, DEVICES AND WIRING SHALL BE DISPOSED BY APPROVED MEANS.

- $\langle 2 \rangle$ disconnect service entrance conduit, support structures and CONDUCTORS BACK TO CT CABINET. SEAL AND REPAIR BUILDING EXTERIOR WALL TO MATCH EXISTING FINISHES.
- $\overline{\langle 3 \rangle}$ DEMOLISH EXISTING CT CABINET, CT'S. REPAIR BUILDING EXTERIOR WALL TO MATCH EXISTING FINISHES.
- $\langle 4 \rangle$ RELOCATE EXISTING POWER COMPANY METER, SEE DRAWING E1.01 SHEET KEY NOTE 2 FOR DETAILS.
- $\langle 5 \rangle$ UNDERGROUND UTILITY CONDUITS CUT AND CAP BELOW GRADE, AFTER THE EXISTING SERVICE ENTRANCE FEEDERS ARE REMOVED BY UTILITY COMPANY. REPAIR TO MATCH EXISTING FINISH GRADE/PAVEMENT.
