GENERAL CONSTRUCTION NOTES

- PLANT AND SANITARY SEWER ARE OWNED BY THE CITY OF ROANOKE.
 THE CONTRACTOR SHALL COORDINATE THE CHANGEOVER OF SEWER
 FACILITIES WITH THE CITY OF ROANOKE WASTEWATER TREATMENT PLANT.
- 2. SYMBOLS AND ABBREVIATIONS FOR ROADWAY PLANS IN THIS CONTRACT ARE IN ACCORDANCE WITH MATTERN & CRAIG SYMBOLS & ABBREVIATIONS.
- THE LOCATION OF UTILITIES, INCLUDING UNDERGROUND UTILITIES, IS INDICATED ON THE DRAWINGS INSOFAR AS THEIR EXISTENCE AND LOCATION WERE KNOWN AT THE TIME OF PREPARATION OF THE DRAWINGS. HOWEVER,, NOTHING IN THESE CONTRACT DOCUMENTS SHALL BE CONSTRUED AS A GUARANTEE THAT SUCH UTILITIES ARE IN THE LOCATION INDICATED OR THAT THEY ACTUALLY EXIST, OR THAT OTHER UTILITIES ARE NOT WITHIN THE AREA OF OPERATIONS. THE CONTRACTOR SHALL MAKE NECESSARY INVESTIGATIONS TO DETERMINE THE EXISTENCE AND LOCATIONS OF SUCH UTILITIES. - 7. SURVEY MERIDIAN BASED ON CITY OF ROANOKE PRIMARY CONTROL NETWORK.
- 8. CONTRACTOR TO MAINTAIN SAFE, PASSABLE ACCESS TO ALL EXISTING FACILITIES THROUGHOUT CONSTRUCTION.
- 9. EROSION CONTROL MEASURES SHOWN ARE THE MINIMUM REQUIRED. CONTRACTOR SHALL COMPLY WITH THE CITY OF ROANOKE EROSION AND SEDIMENT CONTROL ORDINANCES.
- 10. THE 54" PIPE ON THE PLANS ARE DRAWN AS AWWA C302
 REINFORCED CONCRETE PRESSURE PIPE AND FITTINGS.
 AS AN ALTERNATE TO FITTINGS, BEVELED PIPE CAN BE USED.
 IF PRESTRESSED CONCRETE CYLINDER PIPE OR DUCTILE IRON PIPE
 ARE PROVIDED, VERTICAL ACCESS RISERS SHALL BE PROVIDED
